It gives me a great pleasure to record my views about Justice Nagendra Jain. I know Justice Jain right from the day when he started practice in Rajasthan High Court at Jodhpur. He is the son of the worthy father Late Justice J. P. Jain who adored the bench of Rajasthan High Court for a good number of years. Justice N. K. Jain was born on 20' October, 1942 and started his practice at Rajasthan High Court in

1968. He was an outstanding player of Badminton.

Justice N. K. Jain was very courteous right from the day he joined the Bar and I never saw him losing his balance as the Member of the Bar. I have seen him arguing the cases as a professional lawyer with thorough preparation.

He was a Member of Bar Council for a very long time and had a very long inning as a Member of the Bar Council and held various positions in Bar Council from time to time. Before his elevation, he appeared before me as an advocate & argued a number of cases with very much professional ability.

He was elevated as Judge of Rajasthan High Court in the year 1990 and delivered several judgments with great erudite. He was very calm and very courteous even as a Judge of Rajasthan High Court. His behaviour as a Judge was very friendly with the Members of the Bar. Because of his good qualities, he was elevated as the Chief Justice Madras High Court and then to Karnataka High Court and there also he earned a huge fame & name for himself. He was thereafter appointed as the Chairperson of the Human Rights Commission at Himachal Pradesh and thereafter the Chairperson of Rajasthan State Human Right Commission. He proved his mettle.

He by his hard work & concern for human rights, brought this institution a great name in Rajasthan. He has to his credit a number of publications that shows his in-depth knowledge of Law. He totally dedicated himself after retirement as Chief Justice and Chairperson of

Rajasthan State Human Right Commission to social service and he remained the President of Digamber Jain Atishaya Kshetra, Shri Mahaveer Ji . Even today he is dedicated to social service and presently he is the President of Geeta Bajaj Bal Mandir Sansthan, Moti Doongri Road, Jaipur.

Mr. Jain is an eminent jurist and a big social worker who is still associated with the social & religious institutions. The young members of Bar should emulate his example and conduct themselves as a courteous and well-behaved advocate if they want to achieve success in legal profession. Justice Jain is an example of such virtues and unfailing courtesy which endeared him to Bar as well as society. I wish him long and happy life.

माननीय एन. को. जैन साहब मेरे स्कूल के समय के साथी रहे हैं और उनसे 65 वर्ष पुराना रिश्ता है। मेरे पिताजी गैंदीलाल जी शाह वकील उनके पिताजी जे.पी. जैन साहब को अलवर से वर्ष 1950 में आने पर जानने लगे और उनको मंदिरों, वक्फ प्रॉपर्टी एवं मुसलमानों के बड़े मुकदमे देने लगे। दोनों ही महानुभाव दिगम्बर जैन अतिशय क्षेत्र श्री महावीरजी की प्रबन्धकारिणी कमेटी के बहैसियत सदस्य फरवरी, 1958 से साथ रहे। एन. को. साहब ने वर्ष 1985 में बतौर अध्यक्ष, बार कोंसिंल ऑफ राजस्थान की सोविनियर में हमारे पिताजी के वकालात के 50 वर्ष से अधिक पूर्ण होने पर

अन्य वकीलों के साथ उनका भी फोटो व परिचय छपवाया और केन्द्रीय मंत्री भारद्वाज जी से उनको सम्मानित कराया। इस वजह से भी हमारे पारिवारिक सम्बन्ध घनिष्ठ बने, जो आज तक बदस्तूर चले आ रहे हैं। बाद में आप अपने पिताजी की तरह जज रहे व मदास, कर्नाटक जैसी बड़ी अदालतों में और भी ज्यादा जिम्मेदारी के साथ अपना काम निर्भी कता व ईमानदारी से किया।

मैंने पाया कि एन.के.साहब अपनी धुन के पक्के, दूसरों की मदद करने में आनन्द का अनुभव करने वाले, मानवीय मूल्यों के प्रति आस्था रखने वाले, स्वाभिमानी, सहज स्वभाव व वर्तमान में जीने वाले व्यक्ति हैं। आप में खेल भावना कूट-कूट कर भरी है। कठिन परिस्थितियों में भी एन.के. साहब को कभी विचलित होते हुए नहीं देखा। उनमें अपने साथी को परखने व उनसे काम लेने व फिर उनके काम की तारीफ करने का विशेष गुण है, जो उनके प्रोफेशन में आने के पहले व बाद भी देखने को मिलता है। सभी से अच्छी बातें निरन्तर सीखना, आपस में सामंजस्य बनाये रखना व अपने लक्ष्य को हासिल करके, उसे भूल कर नये काम करने का भी विशेष गुण है, जो आपके उत्तम चरित्र को दर्शाता है।

यहाँ मैं यह भी कहना चाहता हूँ कि आप न केवल खेल में अग्रसर रहे, अपितु खेल को अपने जीवन में हॉबी बनाये रखा। इसी तरह वकालात के साथ वकीलों की संस्था का बतौर महासचिव/चेयरमैन बार कौंसिल, साथियों के लिए खूब काम किये। परन्तु पोस्ट से चिपके नहीं, दूसरों को मौका दिया। राजस्थान यूनिवर्सिटी में विधि विभाग के विभागाध्यक्ष व डीन श्री बी.एल.वर्मा साहब के माध्यम से 3-4 विधि विद्यार्थी मेहता, सुरेश, रामावतार आदि और नये वकील जिसमें राकेश बी. कुमार, श्याम आर्य, त्रिपुरारी, बृजमोहन, जिन्दल, जिनेश, पुजारी, सुधीर व मुझे बार कौंसिल राजस्थान व इण्डिया के विभिन्न कार्यक्रमों में बाहर से आने वाले प्रबुद्ध वकीलों, टीचिंग फैकल्टी व डेलिगेट्स की देखरेख में उनके आवास स्थान खासा कोठी एवं ओटीएस में सभी आवश्यक सुविधाएं सुलभ कराने की जिम्मेदारी सौंपी और कार्यक्रमों के माध्यम से हमने काम करने का व दुनियादारी का तजुर्बा हासिल किया जो आज भी यादगार है।

सन् 1981 में आयोजित लॉयर्स सेमिनार के अवसर पर बार एसोसिएशन का सोविनियर हमारी जैना प्रेस में छप रहा था । प्रूफ रीडिंग के लिए 2-3 आर्टिकल कई तकाजों के बाद भी प्राप्त नहीं हुए । उन्होंने कहा कि इसका कोई न कोई कारण जरूर है, आप दूसरा प्रूफ लेकर उसको फाइनल करो, जिससे समय पर सोविनियर छप सके । उनका ऐसा कार्य बोल्ड निर्णय लेने की क्षमता दर्शाता है ।

आपके पिताजी की मृत्यु वर्ष 1975 में होने पर आपने 13 वें दिन ही जोधपुर का सरकारी मकान खाली कर दिया । इसके अलावा आपने स्वयं ''जे.पी.जैन मेमोरियल ट्रस्ट'' जयपुर की जमीन की जगह पल्लीवाल समाज को देने की पहल माननीय मंत्री जी से की । बैंगलोर में जजों को दिये जाने वाले प्लॉट छोड़कर अच्छे संस्कारों का परिचय दिया । आपने त्याग, संतोषी, सब्र व समभाव में रहने जैसे अच्छे संस्कार अपने माता-पिता से अर्जित किये ।

राजस्थान में नम्बर दो के न्यायाधीश होने के बावजूद मद्रास में छ: नम्बर की स्थिति में जाने पर भी फौरन पद ग्रहण कर लिया। उनका कहना था जो हो रहा है अच्छे के लिए हो रहा है और यह सोच उनकी अच्छी प्रवृत्ति का द्योतक है एवं अच्छे गुणों को दिग्दर्शित करता है।

हमने उन्हें राजस्थान जैन सभा, लॉयन्स व रोटरी क्लब, जैन सोश्यल ग्रुप व अन्य कई संस्थाओं में आमंत्रित किया । उन्होंने हर जगह अपनी गरिमामयी सादगी व सहज भाव बनाये रखा । उन्होंने अपने संवाद के जरिये सभी को इन्सपायर व मोटिवेट किया ।

मानवाधिकार आयोग के बतौर अध्यक्ष उन्होंने बहुत सारी कानूनी पुस्तिकाएं लिखीं। उन पुस्तिकाओं को कई एनजीओ व संस्थाओं द्वारा हमारी जैना प्रेस में रिप्रिन्ट करवाकर कई स्कूल, कॉलेज, एनजीओ व आमजन में वितरित करवाया। कुछधार्मिक व कानूनी पुस्तिकाएं एन.के. साहब ने अपने पिता न्यायमूर्ति जे.पी.जैन साहब की स्मृति में भी लिखीं, जो उनके सुपौत्र गौरव जैन द्वारा प्रकाशित करवाकर वितरित करने का बहुत ही सराहनीय व प्रशंसनीय कार्य किया गया।

एन.के. साहब ने धार्मिक, सामाजिक, शैक्षणिक व जनिहत में कार्य कर अनेक लोगों को मोटिबेट किया। जागरूकता के लिए संविधान की धारा 51 ए में वर्णित कर्तव्यों की महत्ता को आमजन को बताया। एन.के. साहब भला सोचने व करने के लिए दिलों में प्रेम होना जरूरी समझते हैं व स्वयं का निरीक्षण करने की भी आदत रही है। जैन साहब में आत्मविश्वास, दूसरों के प्रति आदर व सबके प्रति समानता का भाव देखने में आया।

एन.के.साहब एक व्यावहारिक, संतोषी व कम बोलने वाले व्यक्ति हैं । उन्हें अपने काम के प्रचार-प्रसार का शौक नहीं है और इसी कारण उनके सद्गुणों को शायद ही सभी जानते हों । समाचार विचार संस्थान ने जिस्टस एन.के. जैन साहब के व्यक्तित्व व कृतित्व को प्रकाशित करने का बीड़ा उठाया है वो साधुवाद के पात्र हैं। मुझे भी उनके बारे में बात रखने का मौका दिया । इसके लिए मैं समाचार विचार संस्थान व उनके सहयोगियों का हृदय से आभार प्रकट करता हूँ।

Justice Nagendra Kumar Jain is known to me as a Judge when I came from Delhi as Chief Justice Rajasthan in 1994. I had formed Division Bench with Judges at Jodhpur as well as in Jaipur. On coming to Jodhpur I used to sit with Justice N. K. for some time.

I found him simple, sharp with good understanding and grasping. He always assisted me in disposing the matter quickly. I found that he is quite

capable to dictate orders in the court. He used to talk little to the point and explain in short. He was quite cordial with brother Judges and had good behaviour with learned lawyers in the court.

I made him in-charge in two committees one for selecting drivers and the other for stenographers. I was satisfied that he had taken meritorious persons only for a short period. I also made him incharge to conduct in disciplinary inquiry against the district Judge. Whatever work had been assigned to him he discharged his duties with satisfaction and in time.

On Considering, I found Justice N.K. was fair and reasonable in discharging his duties with strong conviction and boldness.

Justice N.K. was sitting in Jodhpur from the day he took oath in July 1990 and during the period he never worked as sitting Judge in Jaipur Bench. So I wanted to transfer him to sit at Jaipur bench, then brother Justice R.P. Saxena requested me that his wife was not well so he might be considered for transfer. I told him that I had already promised and intimated Justice N.K. He may ask him if he agrees I will transfer him. At that time Justice N.K. decided to forgo his chance. In his books, Justice Jain depicts a socially relevant path to be followed by human beings. While acting as Chairman of Rajasthan Human Rights Commission, he has contributed immensely for the protection of human rights of sufferers of the society. I have personally witnessed his purpose oriented instructions given to the law students regarding concept of human rights and protection thereof, while addressing the law students at Vidyasthali Law College, Jaipur. Thus, as a man, an advocate, a Judge and a social thinker, Justice N.K. Jain has an unparalleled personality whose contribution in the field of Law, Justice and social reform will be remembered for all the times to come.

न्यायमूर्ति श्री जैन राजस्थान उच्च न्यायालय के न्यायाधीश, तदुपरान्त मद्रास व कर्नाटक उच्च न्यायालय के मुख्य न्यायाधीश, हिमाचल प्रदेश के मानवाधिकार आयोग के अध्यक्ष व लोकायुक्त तथा अध्यक्ष, राजस्थान मानवाधिकार आयोग जैसे गरिमामय पदों पर आसीन रहे किन्तु इसका लेशमात्र भी दम्भ मैंने उनमें नहीं देखा। सरलता, उदारता व नम्रता उनकी पहचान है। प्रतीत होता है कि 'विद्या ददाति विनयम् 'इस सूक्ति को उन्होंने अपने जीवन में चरितार्थ किया हुआ है। वर्ष 2003 में जब वे मुख्य न्यायाधीश, कर्नाटक उच्च न्यायालय के पद पर आसीन थे, तब मेरा परिवार सिहत बैंगलौर में उनके पास जाना हुआ। हमारे पहुँचने से प्रस्थान तक जो आतिथ्य उन्होंने प्रदान किया, वह मेरे लिए अविस्मरणीय अनुभव है।



Qualities of Jain Sahib





Justice Shri Nagendra Kumar Jain, a renowned personality and a well known and respected name in legal, judicial, sports, philanthropic, charitable, educational, social and religious circles, is to me, a name synonymous with modesty, simplicity, humility and magnanimity.

Speaking of him, I am reminded of the year

1985. My law final year result was out and I had a client, the renowned law firm, Little and Co., Mumbai, wanting to file a petition in a matter involving important issues and high stakes. They expressed their interest in wanting to engage me provided I was enrolled as a lawyer. They were willing to wait but only for a couple of days for my enrolment. Else they were to entrust the case to some other lawyer as there was an urgency. I was informed that the members of the Enrolment Committee of Bar Council being at Jaipur and Jodhpur, enrolment could at best be by circulation by post, which was time consuming. To obtain the

I had known him, though very briefly, through my father Shri Balbhadra Prasad Gupta, Senior Advocate and heard of him from many others, as a soft and a kind person always ready to offer a helping hand to all, particularly the young lawyers. I was, therefore, encouraged to meet him. Upon my requesting him and impressing upon him the urgency of my enrollment, to my pleasant surprise and true to his reputation and personality, he offered to travel with me to Jodhpur. Within 24 hours, I was enrolled as an Advocate with the Bar Council of Rajasthan and could file my first power in the matter, which resulted in getting me a string of cases. The credit goes entirely to Justice Jain Sahib.

enrolment in a day or two, was, therefore, a challenge.

Traveling with Justice Jain Sahib was a blessing in disguise. I had the fortune to hear from him his experiences at the Bar and life in general which I must confess, laid the foundation of my conduct and approach in the profession and my personal life as well. He would often say, "I have been an active sportsman and all my actions and approach to life are guided by sportsman spirit. One should look at and live life like a true sportsman." His words have became my life motto and a source of guidance at all times.

Joining the Bar, kept me connected and actively associated with him. Over the years of practice at the Bar and interactions with him, I found him to be a selfless person with large spirit of magnanimity and immense patience and perseverance. He was in touch on one-to-one basis with almost all the lawyers, always readily, willingly and enthusiastically helping and guiding them in their endeavours. He would never be seen sitting or standing alone or idle and would always be busy helping, advising or planning some event or the other for the benefit of lawyers.

I'm reminded of several conferences of the Bar Council which he organized successfully and effortlessly, involving the young lawyers, so as to educate, train and motivate them for doing similar things in future. To him, mere practicing in the court was not enough. For the overall development of a lawyer, it was important to be involved in academic and social activities. Speaking for myself, my holding of the historical SAARC law international conference at Jaipur in the year 2002 and the UIA and Law Asia Int. Conference in the year 2009 also at Jaipur, were motivated by my participation in Seminars and Conferences organized by him.

In my 38 years of practice at the bar, I have met and interacted with a large number of legal luminaries and others of repute in their respective fields. But I am yet to come across a person as simple, sober, kind, magnanimous, helpful, modest and humble as he. He has held several very high and prestigious offices such as Chief Justice of Madras, chief Justice of Karnataka, Chairman, Human Rights Commission, Lokayukta, etc. but upto this day he remains unchanged and is the same as he was many many years ago not only to me but to one and all.

As I know him

Justice N.K. Jain: A Paragon of Human Virtues

My association with Justice Jain has been quite long and I have found in him a rare amalgamation of work culture and human virtues worthy of emulation. His achievements in various spheres of his activities, especially Judiciary, have been singularly distinctive. I deem it as a special privilege to put on record my highest appreciation for his personal attributes of character manifested in the qualities of head and

heart. In fact, to be in his company is to be in the company of a noble human being who hardly cares to realize as to how great he is in his own opinion.

I believe this kind of self-effacement is very rare, particularly in a world where people with little worth relentlessly hanker after undeserved publicity and recognition. His outlook of life has been shaped by his sustained adherence to and practice of certain human values like largeheartedness, compassion, moral probity and wider human concern. His humility is so disarming that one who meets him for the first time can hardly believe that he is meeting a person crowned with so many achievements in his life. Arrogance is quite alien to him. He is really a paragon of human values, which are unfortunately, at a low ebb in present time.

There is a popular saying: "some are born great, some achieve greatness and there are people; greatness is thrust upon them." He is born great not because his father was Judge but because he is the worthy son of a worthy father. He has achieved greatness by his contribution not only in the field of Judiciary but also in the society at large. He was born in a Jain family and he belongs to its life style marked with purity and high ideals of human conduct. Thus he has made for himself a special niche in society.

In the field of legal literacy and Human Rights awareness drive, particularly in Rajasthan, he has played a pioneering role. Apart from bringing a number of reforms in the Judiciary, his emphasis on Rights versus Duties has made him a man of much consequence in the country. He is of the firm opinion that if everybody discharges his or her duty, the violation of rights and violation of human rights will automatically be

curbed and reduced. In fact, it is a great message to all of us where people are more conscious of their rights rather than their duties. It is indeed the need of the hour that our rights and duties must go hand in hand. It will certainly help in combating a number of present day's social problems.

It is heartening as well as amazing to note that Justice Jain has been a state level Badminton player, who played this game for 15 years and won commendable laurels for his excellent and outstanding performance.

It is pleasing to see that a player could reach such a high pinnacle of glory in judiciary where he had the rare opportunity of holding the highest positions representing various assignments of much credit. It may be of much interest to note that he has always lived up to the spirit of a player in every walk of his life. He seems to behave in the message of the Gita that "Action is thy duty; reward is not thy concern." This attitude to life has helped him in having an equipoise in day-to-day life. He is righteous, Godfearing and humane to the very core. Even the highest success in life has not turned his head, he is a man down-to-the earth. About his spirit of a player, a few lines of an English Poet co-incidentally flash in my mind:

Play up, play up, play up the game

 $To \, set \, the \, cause \, above \, renown$

To love the game beyond the prize.

In fact, it is very difficult for a person to play a game beyond prize.

I recall here an occasional meeting with Justice Jain long back. It was in Mahrishi Dayanand Law College, Baraf Khana, Jaipur where we had a chance to meet on the campus where National Seminar of Human Rights was being organized. As Chairman of Human Rights Commission, Rajasthan, he was invited as the Chief Guest. He had brought some posters relating to Human Rights with him for distribution. It had happened there I had a chance to look at one of the posters. As a teacher of English, my eyes fell on some of the errors in English in the poster which I pointed out to him and suggested to him correction. Despite all his majestic statue as a Justice, he appreciated my suggestions and promised to get the mistakes corrected in future.

Though it was not a very big thing to remember but he still remembers it and repeats so often his gratitude to me. He has undoubtedly attained his goal by his unstinted devotion to duty and undeterred will to do as well as he can do in life. He seems to be inspired by the message of the Gita that "Yoga is dexterity in action." He is a veritable Karmayogi. H.W. Longfellow, an English poet, perhaps must be having in his mind people like Justice Jain, when he wrote:


"Heights by great men reached and kept Were not attained by sudden flights But, they, when their companion slept Were tailing upward in the night."

I cherish my relationship with him from the very core of my heart. For me it is a priceless possession. There is much to learn from him. He is an emblem of piety, graceful conduct, empathy and concern for others. I wish him a long, purposeful, healthy life coupled with both physical and mental agility so that we may be benefitted by his valuable contribution to society which he has been incessantly rendering in his own way. As an optimist he is our role model. Like Robert Browning , veteran English poet, he might say:

A Pole Star emerged in the skies of Alwar, Rajasthan- on 20th October, 1942 and was vociferously named as Nagendra by his father, Late Justice J. P. Jain.

As the Saying goes by, 'the Star shines by itself, the young Nagnedra Jain gradually grew up into a multifaceted and all-round personality, excelling in all

walks of life — be it sports, be it literature, be it academics or be it society at large! He virtually developed the habit and taste of outshining in whichever field he delved deep.

The young and stout boy eventually opted for Judiciary as three P's his life - Passion, Perseverance and Profession. He is a strong supporter of Human Rights Cause.

He is a down-to-earth, social, humble and noble person, whose heart beats for the upliftment of the downtrodden and the poorest of the poor strata of the society.

He is a lighthouse and iconic figure, to be imitated by one and all in life. He is the person who preaches only those sermons and commandments which he first practices himself. One exceptional virtue I would like to adore about him is that he never loses his patience and believes in the proverb, 'slow and steady wins the race' and always uses the pet words, "slowly-slowly, we will achieve the targets".

His main doctrine is that every Right has got a corresponding Duty and both go hand-in-hand. He believes that the Liberty does not descend to a person; it must be earned before it can be enjoyed!

He has left no stone unturned to see to it that even the poorest person gets easy access to the Legal recourse to redress his grievance in an amicable manner by way of recommending constitution of Circuit Benches at Dharwad and Gullburga regions taking into consideration socio-economic and educational-background as also instigating different NGOs to create legal awareness in the masses.

The other most salient facet of his life-portrait or caricature is that he has written several-books on legal- awareness regarding reforms, human rights, legal literacy, equity and social-justice. He has assumed many incarnations or avtaars in his life — Education, Sportsman, Advocate, Bar Associations, Bar Council, Judge, Chief Justice, Lokayukta, Chairperson of Human Rights Commission and President — Digambar Jain Atishaya Kshetra, Shri Mahaveer Ji.

Justice N.K. Jain and Mrs. Jain together constituted a marvellous combination, carved out by the God, who felt overjoyed while organizing 'get-togethers' on different occasions with their sister and brother Judges.

I fondly remember his undergoing the customary practice of "Kshmavani Parv" or forgiveness, wherein the followers of Jain Dharma Seek pardon from the God for their wrong –doings or misdeeds committed knowingly or unknowingly by them and pledge to dedicate their life for the overall betterment of the humanity at large in the times to come. We brother Judges reciprocate by responding his letter of "Kshmavani Parv" or forgiveness till date.

Last but not the least, I would like to share here that Justice N. K. Jain had always been like an elder Brother, a friend in need to me and, above all, a humble human being, who is accessible to one and all, a unique quality bestowed by the Almighty God!

Glorious Achievements of Jain Sahib as Chief Justice

Justice N.K. Jain was elevated After elevation as Judge of High Court, Rajasthan on 20.07.1990, His Lordship Justice Jain stepped in Tamil Nadu along with Madam and served as Judge and as Hon'ble Chief Justice from 1997 to 2001, when the Hon'ble Chief Justice was transferred to High Court of Karnataka as Chief Justice. As Chief Justice, His Lordship, with the assistance and advice of madam on Menu, used to arrange lunch or

dinner in the lawns of Chief Justice Bungalow inviting all Hon'ble Judges and their wives and used to spend time with joy more particularly Madam used to mingle with Judges' wives freely and affectionately without any ego. Such attitude of madam, the First Lady of Judicial fraternity of Tamil Nadu, exhibited her greatness to one and all, whereby increasing the image of His Lordship about "Virunthombal".

I found His Lordship was very clear in his understanding and his grasp was very good, His Lordship behaved in the court like a gentleman and there was no discrimination between senior and junior lawyers.

I had the opportunity to sit with Hon'ble Justice N. K. Jain in the Second Bench and after elevation, as Chief Justice in First Bench. I will be failing in my duty, if I omit to mention a few instances about His Lordship's judicial approach. There was litigation with regard to P. G. Medical Admission in Tamil Nadu and the said matter was heard by the First Bench, headed by the Hon'ble Chief Justice and decision was rendered by that Bench. In another case, similar issue was raised but was listed before Second Bench headed by His Lordship Justice N. K. Jain. I was one of the two Judges in the Second Bench. After hearing the matter, Justice N. K. Jain took a view contrary to the first bench and recommended to constitute a larger Bench to decide the issue. Hon'ble Chief Justice had gone through the judgement of Second Bench, called our Hon'ble Justice N. K. Jain to the Chamber of Chief Justice and appreciated the view taken by His Lordship and requested him to sit in the Larger Bench and confirm the views of Second Bench. But His Lordship very gracefully withdrew himself to decide the issue referred to Larger Bench. However Chief Justice asked me to sit in the larger bench. The Larger Bench concurred with the view of Second Bench.

A case which arose out of political rivalry in Tamil Nadu was listed before First Bench headed by Hon'ble Chief Justice N. K. Jain. I was sitting with His Lordship as Second Judge. Both parties were fighting before First Bench for an order. After hearing the matter at length, His Lordship pronounced an order in open court immediately and that order of court lead the party later to close the proceeding finding it to be in-fructuous.

One or two practising Advocates in High Court Madras had not conducted themselves before a Hon'ble sitting Judge of High Court, Madras and the matter was brought to the notice of Hon'ble Chief Justice N.K. Jain. After considering the information and materials furnished before His Lordship, a contempt of court proceeding was initiated before a Bench headed by a senior most Judge of High Court, Madras and the matter was heard by that Bench. Thereafter, the said matter had not seen the light of the day due to lapse of time and due to the understanding arrived at between both parties. These kinds of judicial approach made the legal field to understand that His Lordship always took apt decisions depending on the gravity of the matter for rendering justice to litigant or aggrieved person without fear or favour.

Coming to the Administrative side of High Court Madras, there was murmur that appointments of staff are not done judiciously. During His Lordship tenure, there were about 185 vacancies in the High Court. Written examination was conducted by Data Centre at Chennai and Candidates were shortlisted for interview. Lordship constituted a selection committee consisting of one senior most Judge and myself. While I had a discussion with regard to selection of candidates, I informed about following Rule of the reservation to accommodate all classes of candidates. His Lordship readily agreed and instructed to implement Rule of Reservation in recruitment of staff in High Court, Madras. Selection was made following Rule of Reservation and selected 185 candidates. The list was approved then and there by His Lordship. This shows as to how His Lordship rendered Social Justice in Judiciary in the State of Tamilnadu.

We found madam Smt. Aruna Jaina cultured, soft spoken, pious lady with humble and simple life style & affectionate in nature.

I pray to God for his long life and good health.



My best wishes to him for a long, healthy and peaceful life in the days to come while keeping himself usefully engaged to serve the society which he is very much doing.





A Friend, A Philosopher and A Guide

The efficacy of democracy consists in how effective the judiciary is in a democratic polity. Administration of justice is of paramount importance and necessarily the institution of judiciary is to be manned by men of erudition, impeccable integrity and unswerving commitment to uphold the rule of law.

The High Court of Judicature at Madras is one of the few Chartered High Courts and has for several years contributed substantially to the development of law. To lead the State Judiciary as Chief Justice of the High Court, is certainly prestigious but at the same time, the responsibilities are onerous. Hon'ble Justice Thiru N.K. Jain, adorned Madras High Court as its Chief Justice for nearly four years and later on as Chief Justice of Karnataka High Court. During his tenure as Chief Justice, he was also the Executive Chairman of the State Legal Services Authority. I had the singular privilege of serving as Member Secretary of Tamil Nadu State Legal Services Authority and I had moved with Justice N.K.Jain, in my official capacity. Justice N.K.Jain was very keen about ensuring speedy justice to the litigant public. He found that the conventional litigation process would not meet the requirements fully and adequately and thought it expedient to device alternative methods by which the efforts of the regular judiciary to dispose of cases are supplemented. The Legal Aid movement in Tamil Nadu was then at its lowest ebb and Justice N.K.Jain gave a fillip to the legal aid movement and revamped Tamil Nadu State Legal Services Authority, infusing new blood. He made the movement animate and vibrant. Justice N.K.Jain abhorred a hyper technical approach and his focus was on doing justice to the litigant public who are the ultimate consumers of justice, the hypertechnicalities of law notwithstanding. It was only his sound strategy that led to disposal of thousands of land acquisition and motor accident claims resulting in disbursal of crores of rupees to the litigants who sought justice from the courts with a begging bowel.

Deeply touched by the plight of the owners of the land, whose lands have been acquired for the purpose of Neyveli Lignite Corporation (N.L.C.), Justice N.K. Jain, organised a Mega Lok Adalat wherein the target of mass disposal of cases was achieved and resultantly crores of rupees have been disbursed by way of compensation to the owners of the land thereby rushing succor and relief to the land owners. The efforts taken by Justice N.K. Jain, decisively impacted on the backlog of arrears of cases pending on the file of the Courts in Tamil Nadu. Justice N.K. Jain, firmly believed that legal literacy and awareness for the people at large is a sine-qua-non and in that direction caused to be organized innumerable legal literacy and awareness camps throughout the length and breadth of Tamil Nadu. The idea is to give the public the correct perspective while pursuing legal remedies and to prevent frivolous, vexatious legal proceedings.

It was with that object in mind, Justice N.K. Jain, as Executive Chairman and Patron-in-Chief of the State Legal Services Authority caused the publication of several booklets on various enactments of dayto-day utility for the public. Illustratively, Tamilnadu State Legal Services Authority, under the direction and guidance of Justice N.K. Jain, rendered in simple readable Tamil, booklets on Consumer Protection Act, Hindu Marriages Act, Protection of Civil Rights Act, 1955, The Hindu Minority and Guardianship Act 1956 etc., as also legal guidance on certain matters of public interest such as Protection given to the women folk under the provisions of IPC, Protection to women folk under various enactments other than IPC, etc. As many as 15 such booklets have been published to inculcate first principles of legal knowledge to the general public, for after-all, ignorance of law will not be an excuse in a court of law. The various booklets invariably have an introduction from the then Honble Chief Justice N.K. Jain and a foreword from Judges of the High Court and they were released by the Judges of the Supreme Court or Senior Judges of the High Court and received by Judges of the High Court Those booklets are of great and long lasting or some dignitaries. relevance in imparting legal literacy and awareness to the people.

Pained by the plight of under trials languishing in the prisons in Tamil Nadu, Justice N.K. Jain, in deference to the guidelines of the National Legal Services Authority, organized Legal Aid Cells and Prison Adalats at Central Prisons Trichy, and Vellore and in the Special Prison for Women at Vellore.

As a matter of fact, he, in his endeavour to create legal literacy and awareness, directed me as the then Member Secretary of Tamil Nadu

State Legal Services Authority to explain the multifarious activities of the legal services authority through social media, particularly Sun T.V., a popular television channel in the South. That apart, on the instructions of Justice N.K. Jain, a One Day Seminar on different dimensions of Legal Services was held at Dr. Ambedkar Govt Law College, Chennai, during January 2001. It is on his directions that quarterly official Newsletter of Tamil Nadu State Legal Services Authority, "Sattappani Murasu" (voice of legal services) was prepared and released in April, 2001.

Justice N.K. Jain is unassuming and self-effacing and treated everyone including his subordinates with all courtesy and kindness. He is extremely humane and considerate. He took care to create a conducive climate for all concerned to work dedicatedly and produce the best of results.

I deem it a great privilege to have had an opportunity to work under the Stewardship of Honble Justice Thiru N.K. Jain, a multi-faceted personality whose hallmarks are love, kindness and courtesy.

A request has been received to pen a few lines about Mr.Justice Jain, to be published in a book. When I sit down to write a few lines, my memory dates back to sometime in October, 1990-91, the exact year I am unable to remember now, when I with my wife and children got down at Jodhpur airport in the evening and were looking for the protocol assistance which we expected from Jodhpur High Court. At that point of

time I was a Judge at Odisha High Court and Shri Jain was a Judge in Rajasthan High Court, Jodhpur Bench. Shri Jain immediately on coming to know that I am a Judge of Odisha High Court came forward and inquired about my transport and accommodation and instead of going to his quarters with his family called the protocol of Rajasthan High Court to take me to the High Court guest house at Jodhpur by the High Court vehicle which had been allotted to me. I can never forget that help rendered by Shri Jain and from that day onwards I am in contact with Justice Jain. During our stay at Jodhpur we were invited to his house for dinner and to my pleasant surprise, it was Justice Jain's daughter who was serving us hot chapatis from the oven on the dinner table. This illustrates how humble and yet aristocratic the family is. In course of my conversation with Justice Jain that evening, I had learnt that apart from being in active practice before being elevated as a Judge, he was a very good badminton player and he was also the Chairman of Bar Council of Rajasthan. He was also in the executive council of National Law School, Bangalore. When I came to Supreme Court in the year 1995, Mr. Jain had become a fairly Senior Judge and for a long time he was not being elevated as the Chief Justice of a High Court since Justice A.K. Mathur from Rajasthan who was Senior to Shri Jain was continuing as the Chief Justice of Calcutta High Court. Ultimately Shri Jain was appointed as the Chief Justice of Madras High Court and thereafter he was transferred as Chief Justice of Karnataka High Court. I had the privilege of visiting him both at Madras and Bangalore and I had learnt that he was extremely popular amongst the members of the bar. After his retirement, he has

been taking keen interest in several social activities as well as in the game of Badminton. As I have marked him, he is extremely humble, amiable and is interested in developmental activities of the society. He comes of a legal family and his father Late Justice J.P. Jain was a Judge of Rajasthan High Court. He has authored many books and was deeply involved with human rights. He was associated with several NGOs and his active interest in different sphere establishes him as a multi faced personality. His ability enabled him to serve as Chairman Human Right Commission at Himachal Pradesh and thereafter Chairperson of Rajasthan State Human Rights Commission from 2005 to 2010. He is also a religious minded person and was President of Jain Atishaya Khetra from 2011-2014 and at present he is the President of Geeta Bajaj Bal Mandir Sansthan, Jaipur. 

I have great pleasure in contributing a small write up about my close association with him. I have vivid memories of spending a few years in the company of Justice Jain in Jodhpur University and then in the

legal profession. Even though he was senior to me by a few years, we became good friends. I would like to call him a Sportsman Judge. In the University we played badminton together, he of course was a much better player who had represented the state of Rajasthan in the Nationals on several occasions. Friendship comes to him naturally. Amongst our colleagues, he is one of the most amiable and likeable friends. He was elected as a Member of the Bar Council of Rajasthan in 1971 and remained a member of the Council and later its Chairman till his elevation to the High Court. He achieved many prestigious positions during his tenure including that of being the Chief Justice of Madras and Karnataka High Court but he always remained the same Nagendra Bhai for us and each tenure in the judicial career he conducted as a sportsperson by playing the game according to the rules with utmost fairness.



We wish him good health and prosperity. Let Lord Mahavir shower his blessings on him.



जिन्हें हम दूर से जानते हैं, अखबारों, पुस्तकों या दन्त कथाओं से उन पर कुछ कहने लिखने में संकोच नहीं होता । कुछशोध, कुछ क्षम और कुछ कल्पनाशीलता व धारणाओं से कुछ हानिरहित संशोधन के सहारे किसी महापुरूष पर लेख ही नहीं जीवनी भी लिख देते हैं । उन पर यदा-कदा अपनी दृष्टि चिन्तन व मन्थन भी व्यक्त किये देते हैं । पर, जैसा कि मेरे साथ एन.के. जैन को लिखने का प्रसंग आया मैं तय नहीं कर सका कि मुझे कौनसा बिन्दु पकड़ना चाहिये, क्योंकि मैं जितना जानता हूँ व कुछ-कुछ ही जानना जैसा है और वह नहीं भी है । उनके व्यक्तित्व एवं कृतित्व से मेरा सीधा सरोकार नहीं

रहा । जैन मेरे अनुज चि. कैलाश के सहपाठी रहे हैं । इनका परिवार न्यू कालोनी में मेरे पड़ोस में रहा है । इससे मुझे उनको अन्तरंग से जानना ही चाहिये ।

हमारे परिवार में अनुज और उनके साथियों के साथ आत्मीयता तो होती है, उनके प्रति स्नेहभाव भी रहता है। पर उनके व्यवहार और विचारों से अवगत हो पाना संभव नहीं है। जैन के साथ भी मेरा अपनापन होकर भी मात्र स्नेहभाव रहा क्योंकि मेरी अपनी व्यस्तता ने उनके निकट होने का अवसर नहीं दिया। मैं यह जानता रहा कि जैन अच्छा खिलाड़ी है और इनका पंसदीदा खेल बेडिमन्टन है, जिसमें महारथ हासिल की है। इस खेल में जरूरी है कि खिलाड़ी की दृष्टि चिड़िया पर बनी रहे। उसकी जागरूकता ही खेलने को बेहतर बनाती है । जैन में यह कुशलता रही कि चिड़िया की दिशा की ओर ऐसी दुष्टि बनाये रखना, ताकि चिड़िया को उनके बेट पर आना ही होगा और फिर उन्हें शॉट लगा देना है। जिन्दगी में आगे बढ़ने में ऐसे खेल दिशा निर्धारित कर देते हैं। जैन के वर्तमान के साथ भावी जीवन के निर्माण में बेडिमन्टन भी कारण रहा । जैन ने खेल में बेडिमन्टन को चुना, जिन्दगी में भी कुछ चुनना ही था और इन्होंने अपनी विरासत को आगे बढ़ाकर अपनी कुशलता बताने का फैसला लिया । वह एडवोकेट बने और निश्चय के साथ वकालात में ऐसा अवसर बनाया कि अपने स्व. नामधन्य पिताश्री जे पी. जैन के योग्य उत्तराधिकारी बने। पिताजी अपने समय के ख्याति प्राप्त एडवोकेट रहे और सफलता की छाप छोड़ते रहे कि एक समय आया जब वे न्यायाधीश बने । हर विवेकशील व्यक्ति अपने परम रूचिकर उद्देश्य को पाने के लिए अग्रसर होने से पूर्व अपनी बाजुओं की क्षमता को तोल लेना चाहता है। एक बार उस पथ पर चलना हो जाता है तो परम् एकनिष्ठ को भी लोभ लालच को तजते हुए आत्म लोचन द्वारा अपने दोषों को दूर करते हुए सतत प्रयास करना होता है, झटके लगते हैं पर उनके प्रति बेफिक होकर अपनी मंजिल के लिए आगे बढ़ जाता है। अपने लिए तय की गई मंजिल को छुकर सफलता के शिखर पर पहुँच जाता है।

अपनी वंश परम्परा, सामाजिक परिवेश से प्राप्त संस्कारों के जो बीज मन मानस पर अंकुरित हुए, उससे जो दृष्टिवाद हुआ उससे जैन को अपने लिए जीवन प्रवेश का आधार तैयार हुआ प्राप्त हो गया। उन्होंने पिताश्री की विरासत वकालात को अपना लिया। उन्हें योग्य प्रशिक्षण के साथ कानून व सन्दर्भों की सुनियोजित लाइब्रेरी मिल गयी। वकालात में सफल होते गये और वह दिन आया जब वे स्वयंभू न्यायाधीश पद पर आसीन हुए । उन्होंने पिताश्री की वसीयत को संभाल लिया और उसे संजोकर रखा। वे देश के दक्षिणी भाग के दो बडे प्रदेशों तमिलनाडु व कर्नाटक के मुख्य न्यायाधीश पद से अंलकृत हुए। यह भी संयोग है कि पिताश्री जे.पी. जैन जैन जगत के सबसे अधिक अतिशयकारी श्री महावीर जी के न्यासी रहे, इस क्षेत्र के लिए एन के जैन भी न्यासी मनोनीत हुए और समय आने पर क्षेत्र कमेटी के अध्यक्ष चुन लिए गये। यह ऐसी उपलब्धि रही जिस पर किसी को भी गर्व हो सकता है और गौरव का एहसास हो सकता है। इतना ही नहीं जब मैंने चूलिगरी तीर्थ के संरक्षक के नाते एन. के. जैन से कमेटी का सदस्य बनने की स्वीकृति चाही तो उन्होंने सहज रूप से यह कहते हुए इनकार कर दिया कि 'समयाभाव के कारण कमेटी में पद लेना मेरे लिए उचित नहीं है। 'उनके इस वाक्य ने मुझे एक वार के लिए विचलित किया, किन्तु साथ ही उनके प्रति अपने स्नेह को और प्रगाढ़ कर दिया, क्योंकि पद के लालच का लेशमात्र अंश भी जैन में नहीं है। साथ ही उनकी स्पष्टवादिता प्रभावशाली है।

मानवीय संवेदनाओं के प्रति भी एन.के.जैन सही अर्थो में कर्मयोगी है। वह जिस बात पर विश्वास करते हैं उसे करना भी जानते हैं । उनका मानवाधिकार का मिशन किसी प्रदेश की सीमाओं में बंधा नहीं है । अपनी मान्यता को जन-जन तक पहुँचाने के लिए प्रचार-प्रसार के माध्यम में जाने से कही संकोच नहीं रहा । अति की सीमा तक संवेदनशीलता जागरू कता किए रहती है । जैन निराशावादी नहीं है उन्हें भरोसा है कि लोग अपने अधिकारों को समझेंगे और तदनुसार दायित्व का भान भी स्वतः होने लगेगा । जीवन की अच्छाइयों के प्रति आस्था और विश्वास ही उन्हें मानवाधिकार के अभियान के प्रति समर्पित बनाए हुए है वे इसे पूजा मानते हैं और इसके लिए अध्य लिए रहते हैं ।



A Visionary of Social Justice





Mr. Justice Nagendra Kumar Jain, (Former Chief Justice Madras & Karnataka High Court) a man of value and immense dedication, has not only created history in the field of law but is also an avid promoter of human rights. Justice Jain has created awareness of Human Rights and Duties through Booklets, PPT Projects and CDs. He has written about 32 booklets on various legal and other issues like: Women's Rights, Dalit's Rights,

Children's Rights, Arrest, HIV/ AIDS & Government Welfare Schemes, etc. He also motivated the law students of different Universities and Colleges during their internship in Rajasthan State Human Rights Commission (RSHRC), to prepare PPT programmes on various issues like Women, Children, Arrest, Dalits, HIV/AIDS, Cancer, Environment, Juvenile Justice, Ragging, Feticide, Slum Areas, Right to Justice, Right to Information, Custodial Violence in Jail, Drug Abuse, etc. He worked on the project 'Duties mentioned in Article 51-A' and sensitized the students of various universities and colleges. The booklets authored by Justice Jain are available in libraries of U N Congress and various schools, colleges, universities and Government Departments. These booklets have been adopted for wider circulation and distribution (more than ninety thousand) free of cost by Legal Aid Committees. The legal literature offered by him on various contemporary issues of law has been very well received and appreciated by all concerned.

Awareness about Duties as Article 51-A: In a democratic country while a person makes use of his rights, he is equally responsible to his duties. But more often than not we Indians cling tightly to our rights and tend to forget our duties towards our Nation. It is then the people like Justice Jain come forward to remind of our duties along with informing us about our undiscovered rights. Justice Jain greatly motivated the students and the public at large to discharge their duties as mentioned in Article 51-A of the Constitution of India. Keeping in mind that "Duties of one is rights of another", and if one discharges his duties properly, the violation of human rights of others will automatically minimize. More than 100 Institutions, Schools, Colleges, Universities, NGOs, Government Departments, Societies, Clubs, etc. have joined hands in this noble mission and created awareness by reciting pledge of Article 51-A. They have also printed slogans, calendars, pamphlets, banners, flex boards etc. and distributed in public with their

concerned activities and programmes. Even in more than 10 Jails in Rajasthan, 7000 inmates have taken oath with the help of the respective NGOs to the mission. In about 180 meetings and visits of Justice Jain, a number of students and employees of various organizations are observing and taking pledge as per Article 51-A. The effective Human Rights education and discharge of duties properly can change the mind set in values, and behaviour, it can also develop knowledge and skill with attitude of brotherhood.

Elevation to High Court: As High Court Judge on 20-7-1990 and as Chief Justice of Madras and Karnataka High Court (for 5 years). Justice Jain discharged his Constitutional duties with sincerity and dignity having full faith in rule of law. Justice Jain remained Chairperson of Himachal Pradesh Human Rights Commission at Shimla for 9 months with additional charge of Lokayukta before taking charge as Chairperson RSHRC and completed 5 years on 15.7.2010. He has been a member of Executive Council and Academic Council of the National Law University, Bangalore. He is a well travelled person having visited USA, UK, Europe, Canada, Columbo and many other countries of the world. Justice Jain has attended more than 500 conferences, seminars and workshops at the National and International level.

मिलनसार व्यक्ति के रूप में है पहचान

किसी राज्य का चीफ जिस्टस होना अपने आप में अत्यन्त महत्वपूर्ण होता है और वो भी मद्रास का होना, जिसका अब वर्तमान नाम 'चेन्नई' है और जिसके फैसले लॉ बुक्स के अंदर Quote किए जाते हैं यानी उन फैसलों को हर जगह एहमियत दी जाती है। ऐसी जगह के चीफ जिस्टस श्री एन.के.जैन रहे हों तो आप अंदाजा लगा सकते हैं कि क्या वे साधारण व्यक्ति हैं? नहीं, वे असाधारण व्यक्ति हैं, लेकिन जिन लोगों की उनसे मुलाकात रही है या है, वो उन्हें अच्छी तरह जानते हैं कि वे अत्यन्त साधारण व्यक्ति हैं। अंग्रेजी में कहते हैं "Down to earth"

इनका वाकया मैं आपको बता रहा हूं कि मेरे अजमेर के एक मित्र श्री डी.एल. त्रिपाठी का मद्रास जाने का मौका पड़ा तो मैंने उनसे निवेदन किया कि वे मेरे मित्र जस्टिस एन.के.जैन साहब से मिलें। वे बहुत बड़े औहदे पर हैं, जब वे मेरी चिठ्ठी लेकर उनसे मिले तो कोर्ट ऑवर्स के बाद श्री जैन उनसे बड़ी आत्मीयता के साथ मिले। श्री त्रिपाठी खुद आश्यर्चचिकित रह गए कि मेरे जैसे व्यक्ति की भी उन्होंने तारीफ की। अब आप ऐसे व्यक्तित्व को क्या कहेंगे, मैं फैसला आप पर छोड़ता हूं। जस्टिस एन.के. जैन को मुझे 'जस्टिस एन.के.जैन' लिखना बड़ा अटपटा लग रहा है। आप क्षमा करें अगर मैं उनको 'एन.के. 'ही लिखूं तथा वो भी क्षमा करेंगे। क्योंकि एन.के. कहने में मुझे अपनापन लगता है।

मेरी मुलाकात उनसे सन् 1954 में किसी बैडमिंटन मैच के दौरान हुई थी। एन.के. बैडमिंटन के बहुत अच्छे खिलाड़ी रहे हैं। मैंने उन्हें खेलते हुए देखा तो प्रभावित हुआ। मैं भी उन दिनों राजस्थान का बहुत अच्छा खिलाड़ी माना जाता था। मैंने उनके साथ सन् 1955 में राजस्थान की तरफ से नेशनल बैडमिंटन प्रतियोगिता में जयपुर से भाग लिया। उनमें खासियत यह थी कि वो 'राइट हैंड' से सर्विस करते और 'लैफ्ट हैंड' से खेलते थे। सामने वाला खिलाड़ी (Opponent) यह समझकर कि राइट हैंडर हैं, उनके लैफ्ट पर अटैक करता और वो उसे तेजी के साथ रिटर्न करते थे यानी शॉट मारते और फौरन पाइंट बन जाता था। 5-7 पाइंट खेलने के बाद Opponent को पता लगता कि ये तो Deceptive खिलाड़ी हैं। खैर, अपनी-अपनी कला में हर आदमी माहिर होता है।

जब भी कोई बैडिमंटन का टूर्नामेंट होता है तो उस खेल का ड्रा निकाला जाता है। उसमें दो भाग होते हैं, जिसे राउण्ड कहते हैं। दोनों राउण्ड के अंत में जो जीतते हैं, वे फाइनल में टकराते हैं। आपको बता दूं कि सारे अच्छे खिलाड़ी (मुझे भी मिलाकर) प्रार्थना करते थे कि एन.के. के राउण्ड में नहीं पड़ें। क्योंकि इनके साथ यह प्रसिद्ध था कि इनके राउण्ड में अच्छे खिलाड़ी, चाहे कोई नंबर वन हो, अगर पड़ गया तो वो फाइनल में जीत ही नहीं सका। पता नहीं यह जादू था या करिश्मा, भगवान की कृपा रही कि मैं इनके राउण्ड में कभी नहीं पड़ा।

एन.के. राइट हैंड से सर्विस करने के बाद पूरा मैच लैफ्ट से ही खेलते थे, पर लोगों को लगता था कि राइट हैंड से भी खेलते हैं। डबल्स में यह खूबी भी उभर कर सामने आई। पाइन्ट Create करने में बहुत होशियार थे, जिससे कि साथी खिलाड़ी रिटर्न आने पर उस पर स्मैश कर पाइन्ट आसानी से बना लेता था व डिफेन्स भी बहुत ही अच्छा था तथा बखुबी रिटर्न करने में महारथ हासिल थी।

लैफ्ट हैंड साइड (जो खिलाड़ी की कमजोर साइड कही जाती है) उसको वो बखूबी कवर करते थे और डबल्स में इनकी जोड़ी को जीतना लगभग असंभव था। हालांकि मेरे जोड़ीदार श्री राज भागंव भी स्टेट चैम्पियन थे। वो भी मेरे साथ डबल्स में सन् 1955 के नेशनल्स् में जयपुर में खेले। हमारी जोड़ी केवल एक बार एन.के. व एल.सी.गुप्ता की जोड़ी से सन् 1958 में हारी थी। यह वाकया जोधपुर का है। हमारी जोड़ी इसलिए हारी थी कि हम छीतर पैलेस के गुम्बज पर चढ़े थे और पांव थक गए थे। हालांकि मेरे पार्टनर राज भागंव ने गुम्बज पर चढ़ने से मना किया लेकिन मैं नहीं माना और परिणाम हार का रहा।

जोधपुर में जज के पद पर कार्यरत रहने के दौरान एन.के. ने हमारे अजमेर क्लब में नये बैडिमिंटन कोर्ट का बतौर अलका काला IAS के पार्टनर व मेरे और राज भार्गव के खिलाफ खेलकर उद्घाटन किया। इसमें रेवेन्यू बोर्ड के सदस्य श्री राजेन्द्र सक्सेना का सान्निध्य रहा।

जब वो जज थे, तो जोधपुर में बहुत ही मिलनसार व्यक्तित्व के रूप में पहचान रही व आज भी है। 'चीफ जिस्टस ऑफ मदास' से ट्रांसफर होने के बाद कर्नाटक हाईकोर्ट के चीफ जिस्टस रहे। आपके स्वभाव में वो ही अपनापन, वो ही विश्वास आज भी है। इनके बारे में जितना लिखा जाए कम है। लेकिन जो लम्हे मैंने इनके साथ गुजारे उनको याद करता हूं तो यही इच्छा होती है कि काश, वो दिन वापस आ जाएं। लेकिन मुझे खुशी है कि आज भी मेरे प्रति वही अपनापन व स्नेह बना हुआ है।

इनका जीवन सफलतम रहे, इन्हीं शुभकामनाओं के साथ।

Action Speaks Louder Than Words

Brother Justice Nagendra Kumar Jain, Former Chief Justice of Tamilnadu and Karnataka, is one of the rare person, I have seen in my fraternity who fully justifies the phrase "Action Speaks Louder Than Words." Sobar, silent, studios brother Justice Nagendra is known to me ever since 1963, when I had set up my independent office at Plot No. 109, Polo Ground No. 1 in Jodhpur which was close to Ship

House and Late Justice J.P. Jain Sahib Nagendra's father was then a practising lawyer having his residence and office close to this place. I had hired Plot No. 110 also as my residence and family also shifted in Polo ground in 1968. Thus we developed family relations. I have already recollected the great qualities of late Justice J.P. Jain Sahib, Ammaji and late Smt. Aruna Ji, wife of brother Justice N.K. Jain in the books which he brought out in their loving memories. Publication of these two books, demonstrate in abundance, his great bondage and concern for the family. Nagendra Babu was a great sports person as a student and was state champion in Badminton. His interest continued in the games till late in life rather even after he had become a judge and then Chief Justice. With the back ground of sports, he had the sportsman's spirit and knew how to coordinate, co-operate with colleagues both at the Bar and the Bench and that was one reason he had achieved whatever he deserved and desired.

NagendraBabu had to shoulder the responsibilities of the family at a considerable young age, being the eldest child of the family. He was again my neighbour in Zalim Nivas colony. We had a common wall since my self and late Justice J.P. Jain Sb had purchased the plots on the same day in auction from UIT Jodhpur, on which Nagendra constructed his residence. On the other side of my plot there was a vacant plot meant for children's park and I got a gate opened in my own compound and developed it so that all the children of Nagendra Babu, Gaurav and Garima grew up with my children and almost the same age group were the children of late Sh. Harish Rastogi, Late Sh. S.R. Bajwa, Justice N.M. Kasliwal, Sh. Sagarmal Mehta etc. Thus, not only we the elder generation but the younger generation had also close affinity and lived like a family. The period spent at Zalim Vilas Colony was the golden period for not only me but for all other colleagues too.

Sh. Nagendra was my colleague in Bar Council of Rajasthan, Succeeded me at Bar Council of India and again became my colleague on the bench. His respect and regard for me can easily be, made out from the fact that after he took over as Chief Justice of Tamilnadu and visited Jaipur alongwith Smt. Aruna, he called on me and honoured me but putting round my neck a full length Golden Mala made of Gota Kinari, like the one, which Tirupati Balaji wears.

His this gesture is one of my great proud and privilege moment and constantly reminds me of his respect and love for me. Whenever I look at this Mala, which is well preserved, also it reminds me of the sweet memories of our visit to TirupatiBalaji in 1980 when my wife Kanti and Smt. Aruna was also with us. We had gone in connection with a national Seminar at Bangalore.

He has religious bent of mind in as much as he Chaired Bhagwan Mahaveerji Trust. He has also made great contributions for the welfare of Jain community and in general too. He is also a philanthropist and has given a large donation to Mahaveer Viklang Society distributing artificial limbs. As Chairperson of Human Rights Commission, he served the people with great commitment to the poor and the needy. He also inspired school children to discharge fundamental duties.

I wish him all the best for his future life.

I shifted to Jaipur in the Year 1981, he was kind enough to extend his help, support and cooperation in settling me as an advocate at Jaipur.







More than above all, being devout Jain, he took an abiding interest in the research of Jain philosophy that led to espousing the value of Ahimsa and Human Rights in Indian Cultures with special reference of Jainism. This booklet should be hailed as a brilliant product of Justice N. K. Jain. It was his extraordinary assiduity with helped to bring out the booklet "Human Rights and Jain Dharma". In addition a few booklets in memory of his father late Shri J.P. Jain was published by son Gaurav which deal with interesting legal topics or worthy of appreciation and manifest his reverence to his grandfather. I feel that his services should be well utilized in any post where hard work and diligence are called for.

In short, I should say Justice N.K. Jain always enjoyed esteem and respect as pillar of Justice, as preserver of the weak and poor against oppressors and tyrants, as upholders of the freedom and liberty of human being, as a sword for the guilty and a shield for the innocent.

Justice Jain known for Simplicity and Humanity

I am delighted to know that the Samachar Vichar Sansthan is bringing out glimpses of the life and times of Justice N. K. Jain, former Chief Justice of High Court of Madras and High Court of Karnataka.

My association with Justice Jain has been a long one, as he was my father 's student in Maharaja College, Jaipur. My father tells me that "Narendra was a fantastic Badminton player, who represented the

State both in Nationals and Interstate Badminton Championship for over a decade." The spirit of sportsmanship is an integral part of Justice Jain's personality. A great listener, ever accommodating of other's views, Justice Jain has taken life with the equanimity of a great sportsman. In all the years I have known him, I have never found him to be flustered or agitated. He has taken all the facets of life in his own stride.

I first met Justice Jain, as a lawyer, when I entered the Bar of Rajasthan High Court in mid-1980s. Although he was many years senior to us, both in age and in profession, he treated the young members of the Bar with love and affection. Ever encouraging, ever guiding, soon he became our friend, philosopher and guide. His practice in the Civil, Criminal and Corporate laws, ensured his daily appearances before the court. We, the young members of the Bar, would eagerly follow him in the court. His smiling face, his equanimity in the court, impressed all of us. His repeated victories in the election of the Bar Council of Rajasthan, over a decade, testifies to his immense popularity in the Bar. His contribution to the cause of the Bar members was acknowledged by his election to the Bar Council of India, where he represented the Bar Council of Rajasthan for many years. Of course, we were elated when he was elevated to the Bench in 1990.

As a Judge, Justice Jain was known for his patient hearing, his wit, and his ability to grasp the complex legal issues easily. Simple in his language, simple in his demur, he dispensed justice to the poor litigants expeditiously. While he could easily understand the pain and suffering of the common man, he could cut through the elegant arguments of big litigants, and go to the heart of the matter, like a knife through butter. His jovial nature, his robust common sense, his earthy personality endeared him to both the members of the Bar and the Bench.

In 1997, his transfer was a loss to Rajasthan High Court, but a gain to the High Court of Madras. While in Madras he distinguished himself, both as a Judge and as an academician. His stints as Chief Justice of High Court of Madras, and High Court of Karnataka have left an indelible memories in both the High Courts. When I joined High Court of Karnataka, in 2015, my colleagues spoke highly of his contributions as their Chief Justice. They continue to reminisce about him. Even after demitting the office of the Chief Justice, Justice Jain's concern for the people did not diminish. He continued to grapple with the problems of the people as the Chairman of the Human Rights Commission, Rajasthan from 2005 to 2010.

Justice Jain's contribution is not confined to the courtrooms. He has extensively published readily readable books on various topics of law. His books have ranged from the Rights of Women, and the Rights of SC and ST communities, to Intellectual Property Rights. His books, which are simple and elegant, demystify the complexities of law for the average reader. His works have inspired the Legal Service Authorities of different High Courts to publish such simple books for the litigants. Hence, Justice Jain has contributed immensely to the legal literacy movement in our country.

Justice Jain is also a highly religious person, although he does not wear his religion on his sleeves. The respect he has earned within his community is reflected by the fact that he was elected as the President of the Digambar Jain Atishay Kshetra Shri Mahaveer Ji. Influenced by the great Jain tradition, Justice Jain is an epitome of Jain philosophy: Ahimsa Parmo Dharama, and live and let live.

The life of Justice Jain should inspire the young. His journey has been arduous, and winding, but full of simplicity, and humility. Despite having adorned high public offices, his simple living and high thinking, his concern for the fellow being, his deep understanding of life continues to act as a light house for all of us in our dark hours.

I would like to congratulate the publishers for collecting the glimpses of Justice Nagendra Kumar Jain from different persons so as to present a holistic view of a man's life well lived.


When Gaurav son of Justice N.K. Jain (Former Chief Justice, Madras High Court) asked me if I would write a small note on him, I was very touched. I would like to share two incidents, one happened when I was a lawyer, and the other after I had become a judge of the High Court.

When I was practising as a lawyer I on behalf of my law firm, made a complaint to Chief Justice N.K. Jain (as he then was) about a member of the subordinate judiciary. He immediately called the Registrar Vigilance and issued

directions to seize the records and take action at once. It was very heartening that a complaint was acted upon so swiftly by the Chief Justice.. The officer was also placed under suspension.

After I became a Judge, Chief Justice N.K. Jain presided over a conference which was attended by managing directors of State Transport Corporations, Secretary to Govt and members of the Subordinate Judiciary. Many useful and farsighted suggestions were made on how to reduce accidents. The issue was considered from all perspectives. I remember we even discussed how the bus drivers must be taken care of. their shifts should be carefully fixed etc; if we wanted the lapses to come down. It was very gratifying to me that the Chief Justice did not think that accidents were mere statistics but it meant loss of lives and limbs. This was a very humanistic effort where the Court reached out to the common man's grievances.

He had the useful and famous tenure for about four years in Madras High Court from 1997 to 2001, as the Judge as well as the Chief Justice before he was transferred as Chief Justice of Karnataka.

When I was sharing the Bench with him, both of us had the opportunity to hear a number of cases and dispose of the same without any delay.

When he was the Acting Chief Justice of Madras High Court, he used to treat the brother Judges with utmost respect and love. It was regular for him to invite the brother judges and their families to his home to have sumptuous dinners.

Whenever myself and my wife had opportunity of visiting Justice N.K. Jain, either at his residence or in function official / private, we noticed that both Justice Jain and his wife showed affectionate hospitality and sincere respect to us. I still remember that Justice Jain as a presiding Judge had disposed off the several complicated matters in quickest possible time without much delay.

Even after retirement, I am told that he has been spending all his time for the service of the society and also for the development of Jain Temples Darshan and Shree Mahaveerji.

I sincerely pray God Almighty to shower His blessing for his long life with peace and prosperity. There is a saying. "It is Great to be Great but Greater to be humane".

The Golden Period - Karnataka Judiciary

"An institution is nothing but the lengthening shadow of a great man" –

This article focuses on the contribution of Hon'ble Chief Justice Mr.N.K.Jain (as he then was) and the Chairman of Rajasthan State Human Rights Commission, to the Judiciary during his tenure as Chief Justice of Hon'ble High Court of Karnataka.

I had the privilege and good fortune of having deep association with his lordship Hon'ble Justice Sri N.K.Jain, not only as a sitting judge of the High Court of Karnataka but also as the Director of Karnataka Judicial Academy before my elevation as Judge of Hon'ble High Court of Karnataka in the year 2005.

During the period, when I was the Director of the Judicial Academy several innovative steps were taken by Hon'ble Mr. Justice N.K. Jain to strengthen the District judiciary by holding several training programmes in the academy to equip the judicial officers of the state to discharge their functions in the most efficient manner and to ensure that speedy disposal of cases takes place all round the year and thereby delivering justice in the quickest possible time frame to the litigant public who knock at the doors of the courts for redressal of their grievances and seeking justice to them.

It is with the aforesaid aim in view the training programmes were so conceived by Hon'ble Mr. Justice N.K.Jain and the method adopted by the Chief Justice was such that it enabled the judicial officers of the state to render qualitative justice to the really affected people. The quality of the work turned out by the judicial officers of the state during the tenure of Hon'ble Mr. Justice N.K.Jain was of a very high order.

In order to achieve this goal, Hon'ble Chief Justice N.K. Jain evolved a novel method of providing the material beforehand to the judicial officers and thereafter the judicial officers were called for training. During the training period there used to be effective interaction between the trainee judicial officers and the eminent speakers mainly Hon'ble Judges of the Supreme Court and High Courts (sitting and former) and other eminent personalities from various fields of knowledge.

The advantage of circulating the subjects beforehand to the judicial officers enabled the judicial officers to take very active part during the training programme and many of their doubts were cleared during the course of the interaction with the eminent speakers. This method of training, which was the brain child of Hon'ble Mr. Justice N.K. Jain proved to be very effective and the very fact that the number of disposals of the cases by the judicial officers was very high both quantity and quality wise, itself is an indication of the effective training given to the judicial officers during Hon'ble Mr. Justice N.K. Jain's period.

Another important contribution of Hon'ble Mr. Justice N.K. Jain is the spreading of legal literacy among the public of the entire state of Karnataka. Several legal literacy programmes, camps were held during the time when Hon'ble Mr. Justice N.K. Jain was the patron-in-chief of Karnataka State Legal Service Authority, and the President Hon'ble Mr. Justice R.V.Raveendran (as his Lordship was then). This legal literacy programme was also a great success in as much as lakhs of cases were settled during Lok-Adalats and compensation running to lakhs of rupees was received by the claimants/dependants, affected on account of motor vehicle accidents.

Apart from the above achievements Hon'ble Mr. Justice N.K.Jain was also instrumental in organising several state level, national level and international level seminars and conferences in the Judicial Academy when he was the Patron-in-Chief of the academy. I had the good fortune to be associated in conducting several such programmes under the guidance and inspiration of Hon'ble Mr. Justice N.K.Jain and the President Hon'ble Mr.Justice P.Vishwanatha Shetty (presently the Lokayukta of the State of Karnataka). During their period, I also had the opportunity to present several articles/papers for the benefit of the Judicial officers

The programmes and seminars conducted reflect the wide range of subjects chosen under the leadership of Hon'ble Mr. Justice N.K.Jain. In association with the National Judicial Academy, a programme on "Gender and Law" was conducted in collaboration with British Council, High Court Karnataka, and Karnataka Judicial Academy. A one day workshop on "Norweigein Project" on the topic 'Eradication of Child Labour' was organised with the collaboration of Department of Labour and NORAD UNICEF.

In association with Environmental Law Institute Washington D.C. (U.S.A.) and Environment Support Group, Bangalore, the Judicial Academy conducted a programme on Enforcement of Environmental Law. Under the guidance of National Consumer Disputes Redressal Commission, New Delhi, a programme called "Orientation Training Programme for Presidents and Members of District Forums of Southern States" was organised by the Indian Institute of Public Administration, New Delhi and Judicial Officers from the southern states of Karnataka, TamilNadu, Andra Pradesh, Kerala and Pondicherry were the beneficiaries of the said programme.

I have only highlighted some of the many programmes which were held during Hon'ble Justice N.K. Jain's period in Karnataka as the Chief Justice of Hon'ble High Court of Karnataka.

One more feather in the cap of Hon'ble Justice N.K. Jain. The number of Judges elevated to the High court from the Distinct Judiciary and from the Bar reached the highest number of judges appointed to the High Court of Karnataka. This singular achievement of Hon'ble Justice N.K. Jain is unparalleled in the history of Karnataka Judiciary.

Thus the achievements and contributions of Hon'ble Justice N.K. Jain as the Chief Justice of Hon'ble High Court of Karnataka leave this impression. No doubt in my mind that the era of Hon'ble Justice N.K. Jain will go down in the history of Karnataka State Judiciary as the "Golden Period". He will always be remembered for bringing the Karnataka State Judiciary to a very high level and Karnataka State Judicial Academy also became one of the best Judicial Academies of the Country.

Hon'ble Justice N.K. Jain has left Karnataka State "with his footprints on the sands of time" the great saying of the great English Poet, H. N. Long.

Hon'ble Mr. Justice Nagendra Kumar Jain who was the Chief Justice of Madras High Court was transferred to Karnataka High Court as Chief Justice in the year 2001. At that time, I was an Additional Judge of Karnataka High Court. In October 2001, I was made a permanent Judge. Oath of office was administered to me along with brother Justice N. Kumar, Justice D. V. Shylendra Kumar, Justice N. K.

Patil by Hon'ble Justice Mr. N.K. Jain.

My association with Hon'ble Mr. Justice N.K. Jain was a memorable one. He was very simple, quick in grasping and maintained very cordial relationship with all Judges, Members of the Bar and the Staff of the Judiciary. He had maintained a very good relationship between the Bar and the Bench. As a Judge, he was quick in grasping and used to dictate the judgements in the open court without giving any room for any controversy. During his time, he brought many changes in the administration of Justice. He was very free with all the brother Judges. At 10.15 a.m. sharp, he used to come to the coffee hall where all member Judges used to meet over a cup of coffee and then disperse to the court sharply at 10.30 a.m. This was made as compulsory by the Chief Justice for two reasons. One was to exchange pleasantries and the second was to see that all Judges had attended to the court sharply at 10.30 a.m. He was preparing the roaster assigning the work to all Judges in a clever way to see that each Judge shall dispose more cases so that High Court shall not be overburdened with long pendency. He used to request his brother Judges to give priority to dispose off old matters.

Though I was the Junior most Judge, considering my capacity in settling matters to put an end to the further litigation, he appointed me as Chairman of Karnataka State High Court Legal Services Committee which shows how he was judging the performance of his brother Judges.

He was a very good sportsman. Even as the Chief Justice, he used to guide us to play badminton. When he was young he had represented the State of Rajasthan. He was a very good host. He used to invite all the Judges for lunch or dinner by creating occasions. Mrs. Aruna Jain was an ever smiling lady and she was also a very good hostess. He is a true

follower of Jainism. He respected other religions also equally. When I was the administrative Judge of Raichur district, I had invited him to attend a function at Raichur and taken him to Mantralaya to have the blessings of Lord Raghavendra Swamy. Along with him, Mrs. Aruna Jain also accompanied to Mantralava. In the evening, he also pulled the silver Chariot of Raghavendra Swamiji around Brindavan which shows how he respects other religions also. Considering his services of having worked as Chief Justice of Madras and Karnataka High Court, we were expecting that he would be elevated to Hon'ble Supreme Court. Even though he was not elevated, it was not a disappointment for him. On the contrary, he dedicated himself to serve the people by involving with NGOs and other religious institutions at Jaipur. He published many books on legal services authority to spread the legal awareness among the people which he used to send me regularly. Though he retired long back from the service in Karnataka High Court, even today he maintains good relationship with his colleagues. Every year on the day of Kshama Parva Din, I receive a letter which shows the love and affection he has for the colleagues. Unfortunately, he lost his better half Mrs. Aruna Jain recently which is a shocking news for me. I had also sent a condolence message to Mr. Jain.

I am happy to know that Samachar Vichar Sansthan, Jaipur with association of others has decided to publish a catalogue on personality of Hon'ble Justice Mr. N.K. Jain which is really appreciable. Such a catalogue, would be a guide for the young members of the Bar, Judges to know the towering personality of Hon'ble Justice Mr. N.K. Jain so that youngsters can inculcate the good and human values of Hon'ble Justice Mr. N.K. Jain.

With Brother Judges



A True Gentleman With Multifacet And Unique Personality

The life of Sri. Justice N.K.Jain is full of activities and achievements, being a sportsman of repute and a star performer.

He was chosen continuously as a member of Bar Council of Rajasthan for about 19 years from 1971-90 till elevation. He was also a member of the Executive and General Council of National Law School of India University, Bangalore.

When recognizing his acumen as a faculty member and academician, he was nominated as a member of the said Academic Council from 1993 to 1996 by the Chief Justice of India even after his appointment as a judge.

He served in Madras High Court for about 4 years till the end of August 2001.

Justice Jain was of the view that Judges and advocates belong to the same legal fraternity. According to him an advocate discharges his duties with the best of his ability and capability in the interest of his client without having partisan attitude, whereas a Judge has to apply Law on the point to the facts of each case and discharge his duty without any attachment, fear or favour or ill will. He believed that credit for a judgement does not go to judge alone but to Lawyers also as the assistance of an advocate is directly proportionate to the quality of a judgement.

He is also of the view that learning is a constant process, be it in games or any field of activity. So, keeping his mind open, he used to hear advocates with respect and patience for a just decision in the case.

True to the dictum that 'no person is dressed for the day unless he wears a smile on his face', he was always wearing a smiling face - a sterling quality. So, as a Judge, he always worked with cheerfulness, without any tension on his face nor did he create any tension to others in the court hall. At the same time, he was strict as, to him, discipline and values in life are important. Further, he being a God fearing man, was always impartial and careful in the discharge of his duties and did not sacrifice his principles nor did he go against his conscience to be a good judge because he was/is of the firm conviction that no Judge can please everybody and one has to be strict and take strong action in the administration of justice. He believed that justice would be effective, only if power of the courts and respect to them are guarded. He is also of the firm view that any attempt to denigrate the judiciary requires to be avoided and every effort must be made to wipe out

such tendency. So also, he is of the view that to maintain Rule of law, reputation of the judiciary requires to be maintained.

Because of his long standing experience at the Bar and active involvement in the various activities of the legal fraternity, he knew the problems and difficulties faced by litigant public besides the day-to-day problems faced by lawyers. So, as a Judge, he was very much concerned with the quick dispensation of justice in the courts. As such, on becoming Acting Chief Justice even for 3 short periods and thereafter as permanent Chief Justice, his first priority was to see that cases coming to courts are heard as early as possible to put an end to their litigation—a need of the hour.

Because of his sportsmanship and quality of leadership of taking every body with him as a leader of team, dedication, concentration besides remaining calm in all situations coupled with his unassuming character and treating alike his brother and sister judges besides Advocates without any discrimination, be a senior or junior, helped him.

So, with the co-operation of his brother and sister judges and assistance of lawyers, there was a record disposal of 2,41,885 cases from 13-9-2000 till August 2001 under his stewardship when he was Chief Justice of Madras (now Tamil Nadu) High Court, reducing the pendency considerably. Out of the said disposal, 31,353 cases were 7 years old and 1542 cases were 15 years old. Said disposal is in addition to disposal of about 80,000 cases in the same High Court that too, when he was only an acting Chief Justice for brief spells.

Also, on account of his taking interest in that direction, even subordinate courts of that State have disposed off 21,78,047 cases, including 36,000 cases which were seven years old and that was also a record.

It was his lordship, who got sanction for the constitution of 30 Fast Track Courts in the first phase in the cadre of Addl. District Judges to clear pending criminal cases, including cases of under trial prisoners. Further, even a number of long pending criminal cases also came to be disposed off by the Chief Judicial Magistrates in as much as there was execution of about 20,000 non - bailable warrants in the year 2000 and 4000 till August 2001 by police, which was on account of initiative taken by him only.

His lordship was of the view that not only should there be early disposal of cases, such disposal should be cheap also. So, he took interest in the functioning of Lok-Adalats. As a result, a number of Lok – Adalats were held settling 6380 cases, in which compensation worth Rs. 41,53,31,581/- was awarded. Further, His lordship was the pioneer in having Lok-Adalats at central jails covering even lady prisoners so that their cases are also decided early. He had also taken steps for having regular Lok-Adalats at Erode and Tanjavoor jails, besides the constitution of Prison Lok-Adalats at 4 central

prisons and women prison Lok-Adalats. When he was acting Chief Justice, then also he got Lok-Adalats held at Neyvali, where in long pending land acquisition cases were settled and compensation was paid.

Thus, on account of initiative and steps taken by him, there was a record disposal of cases under his leadership in Madras (now Tamil Nadu) High Court and also by the Sub-ordinate Judiciary.

He got 14 Acts translated in Tamil language with their publication and distributed substance and legal aspects. That was done to inculcate legal knowledge and spread legal awareness among local public.

His lordship is not only noble but also simple and sober. He has an amiable personality. Though he held highest posts in the State judiciary besides serving as chairperson of State Human Rights Commissions, he has no ego and does not believe in pomp and show.

He hails from a noble and respectable family. His lordship always remembers the advice of his late father justice J.P.Jain that "Do not expect anything from anybody. Do not be provoked by anyone. Let your heart be not troubled by anybody". So, he never hurt the feelings of others either directly or indirectly. His lordship's simplicity could be understood from the fact that he always remembers me on the eve of Deepawali festival and sends greetings. That apart, though I am younger to him in age, on the eve of every "Kshamavani Parv", his lordship sends letters to Judges including me on the auspicious day of "Paryushan Parv" asking to pardon/forgive him and his family members for any actions, words, mistakes and deeds, that hurt me or my feelings in any way during the year. This speaks a lot about his noble personality.

His life is an open book and inspiring to all. He does not think ill of anybody even for a moment. He is a gentleman to the core with simplicity in life, serving as a role model.



It is a matter of great pleasure that the associates of Samachar Vichar Sansthan of Jaipur have decided rightly (though lately) to publish glimpses of the personality of Hon'ble Justice Nagendra Kumar Jain. I have privilege to mention that I know Justice N. K. Jain since the time he was a practising lawyer of Rajasthan High Court. I witnessed his oath ceremony joining as a Judge of

Rajasthan High Court in the year 1990 at Jodhpur, where I was working as the Supdt. of Central Jail.

The first public function jointly attended by both of us was the Annual function of Shri Pustikar Public School of Jodhpur. His motivational speech to the studens is still ringing in my ears. When all the speakers were praising the distinction holder students and underlying the common words for the importance of study and knowledge, he stressed upon the importance of games & Sports in the over all development of one's personality. Lately I have come to know that he had been national player of Badminton. After completing a very successful and memorable tenure as Chief Justice of two southern states Tamilnadu and Karnatak, in the year 2004 he was appointed as Chairman, State Human Rights Commission, Himachal Pradesh, At that time I was working as Dv. Inspector General of Prisons Rajasthan, Jaipur. Once I received a pleasant call from him that he will be visiting Jaipur by next month. I casually asked about the condition of prisons in the state of Himachal Pradesh and requested him to visit Jaipur Central Jail if possible. Adding to my pleasure of his call he agreed to come. And this was the visit I could feel the simplicity and humility of a 'person' who is Justice N.K. Jain. I can't resist my self to quote the incident. The scheduled time of his visit to the Cental Prison was 10.30 AM. All arrangements were done, quarter guard and gate guard were arranged as per the VIP Protocol. I was aware of his punctuality but when it was 10.45 AM and there was no trace of his arrival, we were worried. Prison officers (Supdt. and Jailors) were frequently going & coming through the main gate and outer gate checking Salami Guard etc. Since the mobile phones were not in vogue in those days, I rang at his landline phone at residence and enquired about his location and came to know that he had already left for central jail five

minutes before 10.00 o'clock as he was to reach there before 10.30. I came out and enquired about any vehicle or staff from the court. The guard commander replied that no one had come. While I was talking to guard commander, a ringing voice of a 'person' standing with the visiting relatives of Prisoners (Mulakatis) surprised me "Bissa Ji mein vahan hun' (Bissaji I am here). I approached him and asked "How you are here, sir?". In a very gentle voice he explained 'when I reached at the gate "police wala" told me "Gari Udhar Khari Karo" (Park your Car there). Looking all these arrangements and you in uniform and tamiham I thought that some VVIP might be coming today. Feeling ashamed of the trouble he had to face I submitted very submissively 'no VVIP is coming sir'. All these arrangements are for you only, sir. you are the VVIP. Problem was that no one could imagine that the Former Chief Justice & working Chairman of State Commission for Human Rights would come in that way driving his own car and would obey the 'orders' of guard commander without expressing his identity. Looking to this examplary simplicity and gentleness the quote appropriately befitting for him is "a saint in the robe of a Judge"


It was good luck to the state of Rajasthan that in the year 2005, he became the Chairman of Rajasthan State Human Rights Commission. With the grace of God, I was also selected in Indian Administrative Services and posted as Collector and District Magistrate in Bundi. He was probably the first chairman who published the booklets and leaflets in almost all the topics in connection with the human dignity and even all walks of life. I received hundreds of copies from RHRC on rights and duties of citizens, legal aid and the pamphlets on Article 51 A of Indian Constitution. The same were distributed in Jan Sunwai Programmes, Ratri Chaupals and in daily hearing through samsya samadhan chapri organized by me.

Now even in the ninth year of his retirement he is the person readily available for delivering lectures on Human Rights, Ethics and like subjects in the courses organized by HCM Rajasthan State Institute of Public Administration (OTS) and is highly appreciated. His life and work may be described in one of the shlokas of Bharthrahri Shatak

ध्येय था, यात्रियों एवं क्षेत्र के ग्रामीणजन को ध्यान में रखते हुए अतिशय क्षेत्र का तीव्र गित से विकास करवाना। तत्समय अतिशय क्षेत्र के प्रचार-प्रसार की अपनी जिम्मेदारी का निर्वहन करते हुए मैंने यहाँ हुए विकास कार्यों को करीब से देखा और महसूस किया कि नि:स्वार्थ भाव, निष्ठा, समर्पण और समाज सेवा की प्रबल इच्छा के बिना यह सब सम्भव नहीं था।

श्री दिगम्बर जैन अतिशय क्षेत्र ''श्री महावीरजी'' राजस्थान का नहीं अपितु भारतवर्ष का प्रसिद्ध तीर्थक्षेत्र है । इस दिशा में प्रबन्धकारिणी कमेटी ने श्रीयुत एन.के.जैन साहब की अध्यक्षता में कुछअतिविशिष्ट कार्यों को मूर्तरूप प्रदान किया ।

अतिशय क्षेत्र से सम्बद्ध अपभ्रंश साहित्य अकादमी के लिए जयपुर के मालवीय नगर, संस्थानिक क्षेत्र में राज्य सरकार से रियायती दरों पर सितम्बर, 2012 में भूखण्ड की स्वीकृति दिलवाने में आपकी महत्वपूर्ण भूमिका रही। इसके पश्चात भूखण्डों का कब्जा 23 अक्टूबर, 2012 को एवं रिजस्ट्री 04 जनवरी, 2013 को कराई गई। इस कार्य के लिए ''सिद्धान्त चक्रवर्ती आचार्य विद्यानन्द जीमहाराजने ''श्रीमहावीरजी''अतिशय क्षेत्र के लिए स्वर्णिम इतिहास रचने की संज्ञा दी।''

आपके नेतृत्व में महावीरजी अतिशय क्षेत्र के इतिहास को जीवन्त बनाए रखने के लिए प्रबन्धकारिणी कमेटी के 1930 से अब तक के सभी 100 ट्रस्टियों की परिचय पुस्तिका का भी 27 दिसम्बर, 2012 को प्रकाशन करवाकर भव्य समारोह में न्यायमूर्ति नरेन्द्र कुमार जैन, कार्यवाहक मुख्यन्यायाधिपति, राजस्थानद्वारा विमोचन करवाया।

जैन धर्म के प्रचार-प्रसार हेतु जनवरी, 2012 में भगवान महावीर एवं मंदिर चित्रित 10 ग्राम चांदी के सिक्के जारी किये गए तथा जनवरी, 2012 में ही भारतीय डाक विभाग, भारत सरकार द्वारा श्री महावीरजी मंदिर पर पिक्चर मय स्टाम्प व चित्रात्मक मोहर का प्रसारण करवाया गया।

यात्रियों के सुविधार्थ एक नया सोलर वाटर सिस्टम, धर्मशालाओं में कमरों की ऑनलाइन बुकिंग, चपाती मैंकिंग वार्मर मशीन, रेलवे स्टेशन से मंदिर तक आने-जाने हेतु अतिरिक्त निःशुल्क दो नई बसें, सोलर स्टीम कुकिंग सिस्टम, 2100 फीट की नई सीवर लाइन व यात्री निवास के 4 ब्लॉक में 40 हॉल, बी-ब्लॉक में 8 एवं सी-ब्लॉक में 12 डोरमेट्री का नवीनीकरण, बिजली की अनवरत सप्लाई हेतु 200 व 320 केवीए के दो डीजी सैट स्थापित करवाये गये । वहीं सुरक्षा हेतु इन्फारेड सीसीटीवी कैमरे भी लगवाए गये । वृद्धजन व शारीरिक रूप से अक्षम यात्रियों की सुविधा के लिए लिफ्ट सुविधा 5 अक्टूबर,2012 से शुरू की गई।

महावीर जयन्ती के पावन अवसर पर हर वर्ष की तरह लोक परोपकार की भावना से विकलांगों को ट्राई-साइकिलें, जयपुर फुट एवं बैशाखी वितरण, विधवाओं को पेंशन व जरूरतमंदों को रोजगार हेतु सिलाई मशीनों का भी वितरण किया गया।

श्रीयुत जैन के नेतृत्व में जैन विद्या संस्थान, अपभ्रंश साहित्य अकादमी के प्रचारात्मक प्रकाशन में कई पत्र पत्रिकाओं व पुस्तिकाओं का प्रकाशन किया गया । वेबसाइट http://apa.jainapa.org का शुभारम्भ किया गया।

जनस्वास्थ्य सेवा विस्तार के लिए श्री महावीरजी द्वारा संचालित ऐलोपैथिक चिकित्सालय में राज्य सरकार से चिकित्सक की प्रतिनियुक्ति करवाई। ग्रामीणों एवं गरीबों के लिए कई नि:शुल्क चिकित्सा शिविर लगाए गये। खराब एक्स-रे व ई.सी.जी. मशीनें ठीक करवाने के साथ ही दो नई मशीनें, हैड प्रेस बेबी वार्मर मशीन व ऑटो एनलाइजर की खरीद की गई। त्रि-वार्षिक विवरणिका वर्ष 2011-13 वेबसाइट www.justicenagendrakjain.com पर देखी जा सकती है।

उक्त कार्यों से न केवल अतिशय क्षेत्र के विकास को गति मिली, बल्कि यात्रियों एवं ग्रामीणजन को ऐसी सुविधाएं मिलीं, जिनके लिए वे वर्षों से इंतजार कर रहे थे।

मुझे यह जानकर बहुत खुशी हुई कि समाचार विचार संस्थान व उनके साथी माननीय न्यायमूर्ति नगेन्द्रकुमार जी जैन की विशेषताओं को उजागर कर रहे हैं, जो अत्यन्त प्रशंसनीय कार्य है। उनके बारे में मुझे भी अपनी भावना व्यक्त करने का मौका दिया, इसके लिए मैं उनका हृदय से आभार व्यक्त करती हूँ।

माननीय न्यायमूर्ति नगेन्द्रकुमार जी जैन हिमाचल प्रदेश मानवाधिकार आयोग के अध्यक्ष पद पर अन्य मेम्बरान श्री बी.एस. चौहान,

श्री आई.डी बाली व मेरे साथ माह नवम्बर, 2005 में सुशोभित हुए । मैं खुशनसीब हूँ कि मुझे भी उनके साथ काम करने का मौका मिला । लोकायुक्त पद का अतिरिक्त चार्ज भी उन्हें दिया गया।

आयोग के सचिव श्री विनोद गुप्ता, आईएएस सभी शिकायतों दरख्वास्तों को कमबद्ध कंसीडर कर सदस्यों के सामने रोजाना की मीटिंग में पेश करते थे और सदस्यगण उनका अवलोकन कर प्रसंज्ञान लेकर सम्बन्धित अधिकारियों को उनके जवाब के लिए भेजते थे । जवाब आने पर यदि जरूरी होता तो उनको सुनकर आदेश करते या सम्बन्धित अधिकारियों को कार्यवाही करने के लिए भेजते थे । समय-समय पर विभिन्न विभागों के अधिकारियों को बुलाकर संवेदना से कार्य करने की चर्चा की जाती और गुड गवर्नेन्स के लिए पीड़ितों के मानव अधिकारों का हनन रोकने की कार्यवाही करने के लिए हिदायत दी जाती थी ।

करीब 08 माह के कार्यकाल में आयोग ने विभिन्न शिकायतों पर संज्ञान लेकर लोगों के मानव अधिकारों का हनन रोकने के लिए दिशा-निर्देश दिये और सरकार ने भी उनकी पालना की । मुझे खुशी है कि बहुत कम समय के कार्यकाल में कई शिकायतों का निराकरण हुआ और शिकायतकर्ताओं को न्याय मिला।

यहाँ मैं 2-3 केसों का जिक्र करना चाहती हूँ:-

- 1. एक प्राइमरी स्कूल की बिल्डिंग गिरने के कारण 04 बच्चों के मरने पर कोई कार्यवाही नहीं करने की शिकायत पर प्रसंज्ञान लेकर मरने वालों के परिजनों को 25,000/- रूपये की अंतरिम सहायता का ऑर्डर दिया, और कहा कि आयोग दूसरी इनक्वायरी की जरूरत नहीं समझता। यह भी हिदायत दी कि गई इन्क्वायरी रिपोर्ट के आधार पर कानूनी कार्यवाही करें। इसके अलावा यह भी आदेश दिया कि शिमला में जो भी खस्ता हालत में बिल्डिंग हैं, उनके लिए जिलाधीश शिमला एक जिला कमेटी बनाकर आवश्यक कार्यवाही करें।
- 2. इसी तरह से अस्पताल में एक मरीज की असामयिक मृत्यु होने पर यह आदेश दिया कि इसकी 15 दिन में जॉच कर रिपोर्ट करें एवं रिपोर्ट सरकार को भेजें, जिससे तुरन्त कार्यवाही हो सके। इसके अलावा यह भी आदेश दिया कि सभी अस्पतालों के बारे में एक कमेटी गठित की जाए। जिसमें सम्बन्धित अस्पताल का अधीक्षक, एक वरिष्ठ चिकित्सक, सम्बन्धित चिकित्सक व एक सरकारी

अधिकारी ऐसे मामलों की 15 दिन में अपनी जॉच रिपोर्ट सरकार को दें, जिससे सरकार उस पर उचित कार्यवाही कर सके।

3. पुलिस अधिकारियों से चर्चा के दौरान आई.जी. से कहा गया कि वे अपनी रिजर्व फोर्स में से 3-4 आदिमयों के मार्फत शिमला के सभी 12-13 वार्ड में हर माह एक बार जाकर वहाँ के निवासियों, खास तौर पर बुजुर्गों के बिजली, पानी, टेलीफोन का बिल जमा करायें और उनकी अन्य समस्याओं का भी समाधान करें। इससे बुजुर्गों को सहायता/सुविधा मिलेगी एवं पुलिस उस इलाके से फ्रेन्डली हो जायेगी। यह बहुत खुशी की बात है कि उक्त दिशा-निर्देशों की पालना कर सरकार ने इन तीनों समस्याओं को दूर करने के लिए अलग-अलग आदेश पारित कर दिये।



जस्टिस जैन व अरूणा भाभीजी के साथ कई मंदिरों विलासपुर, ज्वाला माता, नैनादेवी, कांगड़ा माता आदि जगह जाने का मौका मिला व मेरे आर्चंड के फार्म हाऊस पर भी पधारे । उनसे जो प्रेम व आत्मीयता मुझे मिली, वह हम और हमारा परिवार ताजिन्दगी याद रखेंगे।

व्यक्ति चाहे दुनिया के कितने ही सर्वोच्च पद पर आसीन हो किन्तु समाज में वो अपने सद्कर्म से ही जाना जाता है। इसी संदर्भ में न्यायाधिपति श्री नगेन्द्र कुमार जैन के पद नहीं वरन उनके व्यक्तित्व की कुछ विशेषताओं से मैं परिचित हूं और जब जाना कि उनके जीवन पर एक पुस्तिका लिखी जा रही है तो निजलेखनी आतुर हो गई।

श्री नगेन्द्र जैन की जन्म स्थली अलवर है और मैं भी वहीं से हूं। मेरी जन्मस्थली मुंशीबाग के निकट ही श्री नगेन्द्रजी का ननिहाल है। पास ही बीच के मोहल्ले में श्री नगेन्द्र जी का जन्म हुआ था। बाद में वो होप सर्कस

बुर्ज में रहने लगे उनके पिता एडवोकेट जेपी जैन के मेरे पिता एडवोकेट श्री उमादत्तजी से पारिवारिक संबंध थे। इसी नाते हम सभी बहिन-भाई श्री जेपी जैन को चाचाजी एवं उनकी पत्नी श्रीमती पुष्पा देवी को चाचीजी कहकर बुलाते थे।

यह परिवार काफी समय तक अलवर में रहा। होप सर्कस में श्री जेपी जैन का ऑफिस था एवं निवास भी। बाद में इनके आवास के निकट ही अलवर की चर्चित गणिका का निवास था। बालक नगेन्द्र को स्नेह से वह गणिका कभी-कभी घर भी बुला लेती थी। परन्तु चाचाजी ने कभी एतराज न कर अपनी उदारता का उदाहरण पेश किया। कुछ समय बाद यह परिवार जयपुर प्रस्थान कर गया और हमारे पारिवारिक संबंधों में शिथिलता आ गई। मेरी बड़ी बहिन शारदा और उनके पित जो बीडीओ थे, उन्होंने पुत्र की पढ़ाई के लिए जयपुर में आवास लिया और श्री जेपी जैन के परिवार से फिर निकटता बन गई। में महारानी कॉलेज में पढ़ रही थी। हॉस्टल में थी, जीजी के यहां जाना होता था। अत: मेरा परिचय भी इस परिवार से हो गया।

श्री नगेन्द्र बैडिमंटन के अच्छे खिलाड़ी रहे, किन्तु जब देश से बाहर प्रदर्शन के लिए चयन हुआ तो इनसे कम योग्य व्यक्ति का चयन किया गया। जेपी जैन साहब अच्छी पॉजीशन में थे, यदि चाहते तो वे अपने पुत्र के पक्ष में फैसला करवा सकते थे, लेकिन उन्होंने ऐसा नहीं किया। ना ही नगेन्द्र जी ने इसे चर्चा का विषय बनाया। पिता के प्रभावशाली अस्त्र का प्रयोग किए बिना परिस्थिति के फैसले को स्वीकार किया। एक कुशल खिलाड़ी की क्या मनोदशा रही होगी ? पर न पुत्र और न पिता ने निर्णय बदलने की चेष्टा की। यह साधारण बात नहीं थी। यहीं से प्रबल एवं निर्मल संस्कारों की नींव उजागर होती गई।

अपने पिता के प्रति स्नेह, आदर व समर्पित भाव से उनकी जन्म शताब्दी के अवसर पर उनको स्मरण कर पुस्तिका निकालना योग्य पिता का सुयोग्य पुत्र होना प्रदर्शित करता है। इसके अलावा इनके द्वारा संचालित जे.पी.जैन मेमोरियल ट्रस्ट को जिसे इनकम टैक्स एक्ट में 80 जी धारा के तहत छूट मिली हुई थी, जमीन आवंटन होने पर, समाज को पहले देने की पहल करना अपने आप में एक कठोर निर्णय रहा होगा। उसी तरह आपने बैंगलोर में माननीय जजों के मकान लेने के अधिकार का इस्तेमाल न कर जैन धर्म के अपरिग्रह के सिद्धान्त का आदर्श उदाहरण पेश किया।

चाचाजी न्यायमूर्ति जे.पी.जैन साहब का आकिस्मिक निधन 17 सितम्बर,1975 में हो गया। तत्पश्चात उन्होंने सरकारी मकान 14 दिन बाद तुरन्त खाली कर दिया। आज के समय में देखते हैं कि किस प्रकार राजनेता सरकारी मकान को खाली नहीं करते।

एक दृष्टांत और है, जो श्रीमती अरूणा जी की स्मृति पुस्तिका से जाना। वर्ष 1984 में श्री नगेन्द्र जी बिना पत्नी को सूचित किए अमेरिका चले गए और 62 दिन बाद लौटे। यह कृत्य ठीक नहीं था। पुस्तक में इसे बिना अंकित किए भी काम चल सकता था, लेकिन श्री नगेन्द्र जी ने अपनी गलती को पूरी ईमानदारी से स्वीकार कर चारित्रिक विशेषता को दर्शाया। यह भी एक आदर्श उदाहरण है। मेरे ख्याल से जैन धर्म के आलोचना पाठ में वर्णित शब्दों को अपने जीवन में उतारने का प्रयास कर धार्मिक व मानवीय मुल्यों को साक्षात्कार किया।


अंत में महिला होने के नाते एक बात, जिसने मुझे अंदर से छुआ, वह है श्री नगेन्द्र जी का अपनी पत्नी अरूणा जी की स्मृति में पुस्तिका का प्रकाशन करवाना। िकतने ही पित अपनी पत्नी से प्रेम करने का दम दिखाते हैं, लेकिन मरणोपरान्त उनकी स्मृतियों को अंकित करना, एक-एक चित्र को सहेज कर रखना कोई बिरला व्यक्ति ही करता है।



Born on 20th October 1942 at Alwar as the eldest son of Late Justice Hon'ble Shri J.P.Jain, Hon'ble Justice Nagendra Kumar Jain is a versatile personality endowed with manifold and varied successes in his life. He is a respected legal luminary, a reputed sportsman, a great protagonist of protection of the human rights of the citizenry of the country, a

widely respected social leader and social reformer and at the same time he takes keen interest in education upliftment of the society and is actively associated with a number of educational institutions as its Chairman or Executive Director.

He is noble and courteous by temperament, soft spoken and fathoms love and affection for all, especially his senior and junior colleagues alike. He is very earnest and forthright in his character and does not mince words if he feels that something is wrong somewhere.

He and his late wife, Respected Aruna ji, both were very hospitable and arranged elegant parties at their residence to their brother judges and their spouses, where they were served with lavish and sumptuous vegetarian homemade dishes with great pleasure and honour, so much so that Respected Bhabhiji was affectionately called as 'Annapurana' by brother judges and their wives.

As a lawyer he was member of Bar Council of Rajasthan for 19 years. He was also member of the Executive Council of the Supreme Court of India, as also member Bar Council of India as well as member of Bar Council of India Trust. He was also member of the Executive Council and the Academic Council of National Law School, Bangalore. All these are illustrious and adorable achievements at his credit as a lawyer.

Keeping in view his brilliant and excellent record at the bar, he was elevated as a judge of Rajasthan High Court on 20th July 1990 and sat with me in Division Bench for about two and a half years. He has been a great asset to me as my colleague who is endowed with sharp intellect and mature understanding. He remained Chief Justice of Madras and

Karnataka High Court for about five years and his disposal of record has always been superb. He has also chaired the Human Rights Commission of Himachal Pradesh and Rajasthan for about six years.

As a social leader, he worked as President of Digambar Jain Atishaya Kshetra Shri Mahaveer Ji. He is presently the President of Geeta Bajaj Bal Mandir Sansthan.

He is widely respected as the head of big family left by his father. He has fostered great bonds of affection and love with families of his brothers and sisters. He is great as a father and adorable as a loving and caring husband.

He is also a good writer and has published about 32 small books which include the memoirs of his late father, Hon'ble Justice J.P.Jain, as also his wife, Smt. Aruna Jain.

Concern with the Cause of Human Rights Society and the Students Visiting Him

I feel privileged to have a long association with Honorable Justice Shri N. K. Jain. I witnessed his working in different capacities without any change in his behaviour. He possesses humanitarian face and approach in his dealing with all irrespective of their status. He lived his life strictly with professional approach. However, he never allowed anger and inhuman approach in discharging the obligations

attached to his offices in different capacities.

I saw him as a teacher teaching the Indian Penal Code at Faculty of Law in the then University of Jodhpur, Jodhpur. I feel no hesitation to state that apart from an advocate, he is an excellent academician having excellent capacity to express and explain all the issues of law with relevant case laws in a very simple manner. He had clarity of thoughts and capacity to communicate effectively. Therefore, his thoughts and contents of teaching travelled to the minds of the students in the most effective manner.

I had an opportunity to see Justice N.K. Jain as an Advocate both at Jodhpur and at Jaipur. He used to focus on the practice of law rather than the practice of the facts, which upshots in to his great career in the field of law. As per his special characteristic, he used to be very simple and kind in his dealing with all specially the clients and the students.

He served the Bar Association and the Bar Council of India in different capacities and rendered his services to the fellow advocates and the institutions with great concern and responsibility.

The services rendered by Justice N.K. Jain as Judge and Chief Justice of different High Courts will be remembered by all, especially in speedy disposal of cases and leading path to establish the High Court Bench in the State of Karnataka.

I have seen his services as the Chairperson of Rajasthan State Human Rights Commission. Two things I would like to mention which I have observed during my meetings with him in this capacity. Firstly, he —used to feel concern with the cause of human rights, society and the students visiting him in the Commission. Secondly, he was the first whom I met, who did not support for the casual concept of human rights prevailing in the society and made it clear that the right obligator in the human rights must be the State. He used to focus the jurisprudential concept of human rights rather than the self evidently concept of the same.

At this juncture, I would like to mention one experience that once I telephoned him to meet in person when he was leaving for Airport in Jodhpur. He waited at his residence until I reached there and thereafter, I boarded back in his car for the Airport.

He possesses' good health since he is a very good sportsman, lives peaceful, disciplined, punctual and tension free life. Many distinctions have been conferred on him in the field of sports since his career as a student. I remember that after living in Court for the whole day and serving faculty in the evening as a teacher at Jodhpur, he used to spare time for Squash/Badminton without failure.

However, I pray to God for an excellent health for him.

An Eminent Chief Justice and Excellent Administrator

The Honourable Mr. N.K. Jain, Chief Justice (Retired) of Madras and Karnataka High Courts, is well known to me for over 20 years, ever since His Lordship was transferred to Madras High Court in 1997, as one of the senior Puisne judges, as I was Assistant Registrar (Judge's Section) then.

After serving as Acting Chief Justice for a brief period, he was posted as Regular Chief Justice in May 2000 until his transfer to Karnataka in 2002.

I was promoted as Deputy Registrar (Protocol) in 1999 and I had the great opportunity to get acquainted and work under His Lordship. I liked him for his immense legal knowledge, honesty, integrity, simplicity, shrewdness and uprightness in all matters.

His Lordship had saved a lot of money for the State Exchequer by minimising the requirements of the Judiciary when the subject was discussed. Dinner meets were held only in the High Court campus, avoiding extravagant expenditure at star hotels. When funds were allotted for a conference or such other thing, some amounts were in fact refunded to the state by limiting the expenses. His Lordship had an easy and forgiving attitude if some minor offence was committed by the staff members, but at the same time he dealt with them firmly and with an iron hand, when serious offences were committed. One such example was that of His Lordship's own personal staff in the cadre of Deputy Registrar being dismissed from service, for having misbehaved with a lady member.

Regarding the District Judiciary, His Lordship relied upon experience, ability and knowledge in dealing with the subjects brought for his consideration. He would listen to the divergent views and general opinion of all, before coming to the right conclusion. All the Honourable Judges and Subordinate Judiciary were at ease during his tenure and appointments were given without any huff or prior notice, and matters were discussed then and there and minutes drafted for approval.

His Lordship had no compromise on Judicial Principles and all judicial norms were strictly adhered to, which made the Honourable Judges, Subordinate Judiciary, litigant public and the accused very happy. During his tenure as Head of the COFEPOSA Board, Legal Services Committee, Legal Aid Board and various other posts, he left no stone unturned and all matters requiring due consideration were discussed, even burning the midnight oil at times, and diligent orders were passed swiftly, keeping in mind the harm that may be caused by the inordinate delay in the matter. He had good rapport with the brother Judges all along and even now he is in touch with some of them. Legal literacy was spread through advertisements in the papers, wall posters, hand bills, etc. and the general public was greatly satisfied.

Regarding recommendation of names to the High Court for Judgeship, there was consensus among the committee members and the names thus sent were also cleared by the State quickly. In fact, all vacancies in the High court and subordinate courts were filled up without any delay. Additional posts sought for and sanctioned by the government were also filled up, following the prescribed norms and hence there was no room for displeasure among the less fortunate. Necessary infrastructure was sought for and obtained within a short period from the concerned authorities.

As to the promotions, transfer and postings of the Judicial Officers and Officers of the High Court, strict seniority, merit and ability were taken cognisance of, apart from the patient hearing, and to a large extent all were kept happy, which resulted in heavy disposal and clearance of backlog of cases. In fact, the promotion list was prepared and kept ready even as on the dates the vacancies arose and they were filled up immediately which was a great boon to all concerned.

His Lordship had sit in all branches of Law during his service in the High Court. His quick grasp at the subject, his great legal acumen and the immediate reference to many citations which were at his fingertips added feathers to his cap. The junior advocates were given an equal and patient hearing like their senior counterparts. Advocates were eager to put forward their cases and adjournments were at the bare minimum, leading to heavy disposal and our state becoming No. 1 in the disposal of cases. I am refraining myself from stating the elaborate statistics in this regard. Computer literacy was in the initial stage and our personnel were trained well to equip themselves and necessary equipment began to pour in.

His Lordship's family members were all very simple, unassuming, generous, affectionate and very considerate which is a rare phenomenon in the higher echelons of society. They never had the clout of being from a well-to-do influential family. Mrs. Aruna Jain, an embodiment of high virtue, is a shining example of how a lady should be and she was a GEM whom we lost about a year ago. Mr. Gaurav, His Lordship's only son is an upcoming and hardworking advocate, having knowledge in all segments of law, which is like his illustrious father and grandfather. Ms. Garima, his only daughter, is following her mother and guiding her family in a good manner.

During the service in Madras, His Lordship and family, pious as they are, visited great temples like Tirumala, Sri Kalahasti, Guruvayur, Sabarimala, Palani, Madurai Meenakshi Amman etc. They would not expect elaborate protocol arrangements during their journeys and put up with inconvenience many times.

It was a great experience for me to move with this noble soul whom I shall never forget and which I shall ever cherish.
